WHEREAS, the recognition was granted to the institution namely, Bangalore City College of Post Graduate in Education, Ramakrishna Education Trust®, No. 160, Chelekere Main Road, Kalyan Nagar Post, Chelekere, Banglore – 560043, Karnataka vide SRC vide order no. F.SRC/NCTE/2009/M.Ed/RO/9521 dt. 23.02.2009 for conducting M.Ed. course of one-year duration with an annual intake of 25 students from the academic session 2009-2010.

- 2. AND WHEREAS, the enhancement of intake of 10 seats from existing 25 to 35 is permitted to Bangalore City College of Post Graduate in Education, Ramakrishna Education Trust®, No. 160, Chelekere Main Road, Kalyan Nagar Post, Chelekere, Banglore 560043, Karnataka vide order No. F.SRO/NCTE/2010-2011/21558 dt. 28.09.2010 from the session 2010-2011.
- 3. **AND WHEREAS,** on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 02.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.05.2015 for conducting **M.Ed. programme** of two years duration with an annual intake of 50 students (one unit) from the academic session 2015-2016.
- 4. AND WHEREAS, the SRC in its 348<sup>th</sup> meeting held on 05<sup>th</sup> & 06<sup>th</sup> December, 2017 has considered the matter and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 16.12.2017 to B.Ed., M.Ed. & D.El.Ed. Programme. The institution has submitted vide letter dated 04.1.2018 a request for extension of time toward submission of reply of Show Cause Notice.
- 5. **AND WHEREAS,** the SRC in its 381<sup>st</sup> Meeting held on 31<sup>st</sup> October & 01<sup>st</sup> November, 2019 decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 07.09.2020. The institution has submitted its reply received on 03.10.2021.
- **6. AND WHEREAS,** the SRC in its 414<sup>th</sup> Meeting held on 26<sup>th</sup> 27<sup>th</sup> September, 2022 considered the matter and decided to withdraw the recognition. Accordingly as per the decision of SRC a withdrawal order No. F.SRC/NCTE/APSO7204/M.Ed./KA/2022/137609-137613 was issued to the institution on 01.12.2022.
- 7. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-36/E-289628/2023 Appeal/3<sup>rd</sup> Meeting, 2023 APPLSRC202314552 dated 07.03.2023 appeal remand back the order appealed against. The institution vide letter dated 07.04.2023 submitted reply to the appeal remand back order.

- **8. AND WHEREAS,** the SRC in its 423<sup>rd</sup> Meeting held on 12<sup>th</sup> April, 2023 considered the matter and decided to issue a letter. Accordingly, as per the decision of SRC a letter was issued to the institution on 21.04.2023.
- 9. AND WHEREAS, the institution vide letter dated 03.08.2023 & 31.07.2023 has submitted the Bank Statement of the institution and individual faculty members and it is also submitted the affidavit of Rs 100 Stamp paper mentioning the name and Account No. of faculty members.
- 10. AND WHEREAS, the SRC in its 428<sup>th</sup> Meeting held on 25<sup>th</sup> August, 2023 has considered the matter and decided as under:-

"The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations:-

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Bangalore City College of Post Graduate in Education, Survey No. 160, Chelekere Main Road, Kalyan Nagar Post, Bangalore-560043, Karnataka for M.Ed. programme 1 basic unit of 50 students. Orders may be issued accordingly."

- 11. NOW THEREFORE, this order is issued permitting the institution i.e., Bangalore City College of Post Graduate in Education, Survey No. 160, Chelekere Main Road, Kalyan Nagar Post, Bangalore-560043, Karnataka for Continuation of recognition for M.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 12. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 13. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff

with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 16. The institution shall make available the list of students admitted on its official website.
- 17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
