WHEREAS, the recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely, University College of Education, Sri Krishnadevaraya University, Ananthpur, Andhra Pradesh-515003 vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2007-2008/11911 dt. 25.09.2007 for conducting Secondary B.Ed. Course of one year duration with an annual intake of 100 students.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution had consented to come under new Regulations vide a notarized affidavit dated 21.01.2015. A revised provisional recognition order was issued on 06.05.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- **3. AND WHEREAS,** the SRC in its 298th Meeting held on 08th to 10thJanuary, 2016 considered the matter and other relevant documents of the institution and decided to issue SCN for inadequate faculty in M.Ed. B.Ed. and B.Ed.-(DE). Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 03.02.2016. The institution submitted its reply along with documents on 25.02.2016.
- **4. AND WHEREAS,** the SRC in its 307th Meeting held on 09th March, 2016 considered the reply of the institution and decided as under: -
 - 1. The reply is not at all satisfactory. Regular B.Ed. & M.Ed. are being run by adhoc teachers. The B.Ed. (DE) is being handled by teachers attached form other Colleges.
 - 2. Withdraw Recognition.
- **5. AND WHEREAS,** the SRC in its 326th Meeting held on 04th & 05thJanuary, 2017 again considered the matter and decided to issue Withdrawal order. Accordingly, as per the decision of SRC a withdrawal order was issued to the institution vide order no. F.SRO/APS07494/B.Ed./APS00414/M.Ed./AP/2016-2017/91302 dt. 24.01.2017 for B.Ed. and M.Ed. programme.
- 6. AND WHEREAS, aggrieved by the withdrawal order of SRC, the institution preferred an appeal before the Appellate Authority of the NCTE and Council remanded back the case to the SRC, NCTE with a direction to consider the teaching faculty provided by the appellant and take further necessary action as per the NCTE Regulations, 2014 vide order no. F.No.89-216/2017Appeal/13th Meeting -2017/57081 dated 21.08.20 \(\) 7.

- 7. AND WHEREAS, the University submitted its written representation along with faculty list and other documents on 20.12.2017. The SRC in its 352nd Meeting held on 04th& 05thJanuary 2018 considered the matter and decided to issue Show Cause Notice to the institution. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 16.01.2018. The University submitted its reply on 05.02.2018.
- **8. AND WHEREAS,** the SRC in its 358th Meeting held on 01st to 03rd March, 2018 considered the matter and decided to issue formal order restoring recognition for B.Ed. (2 units) with (retrospective) effect from 2017-2018. Accordingly, as per the decision of SRC, a restoration/continuation order was issued to the institution for B.Ed. (2 units) course for two years duration on 03.03.2018 w.e.f. 2017-2018.
- 9. AND WHEREAS, the SRC in its 388th meeting held on 14th-15th September 2020 considered the matter and decided to issue Show Cause Notices to all the institutions wherein recognition was accorded by the SRC under Regulations 2014 with the direction to submit all requisite documents. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 22.02.2021. The institution submitted its reply vide letter dated 15.03.2021.
- 10. AND WHEREAS, the SRC in its 411th meeting held on 23rd & 24th May 2022 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 02.06.2022. The institution did not submit reply to the Final Show Cause Notice.
- 11. AND WHEREAS, the SRC in its 412th meeting held on 05th-06th July 2022 considered the matter and decided to withdraw the recognition of the institution. Accordingly, as per the decision of SRC, a withdrawal order was issued to the institution vide order no. F.SRC/NCTE/APS07494/B,Ed/AP/2022/132688-132692 dated 20.07.2022.
- 12. AND WHEREAS, aggrieved by the order of SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appeal Committee of the Council concluded to remand back the case to SRC with a direction to consider the documents submitted in appeal and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time vide order No. 89-226/E-269814/2022 Appeal/9th Meeting, 2022 APPLSRC202214450 dated 30.11.2022. The institution submitted its reply vide letter dated 07.12.2022.
- 13. AND WHEREAS, the SRC in its 421st meeting held on 10th February 2023 considered the matter and decided to issue Final Show Case Notice to the institution. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 20.02.2023. The institution has submitted its reply received on 27.02.2023 and 17.07.2023 to the Final Show Cause Notice.
- 14. AND WHEREAS, the SRC in its 427th meeting held on 20th July 2023 considered the matter and decided to issue a continuation order to the institution for B.Ed. programme for 2 basic units of 50 students each subject to submission of orders from the Govt. of A.P. to the effect sanction of teaching position. Accordingly, as per the decision of SRC, a letter was issued

to the institution on 01.08.2023. The institution has submitted its reply vide letter dated 26.07.2023 as per the uploaded decision on website.

15. AND WHEREAS, the SRC in its 428th meeting held on 25th August 2023 considered the matter and decided as under: -

The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution University College of Education, Sri Krishnadevaraya University, Ananthpur, Andhra Pradesh-515003 for B.Ed. programme 2 basic units of 50 students each. Orders may be issued accordingly.

- 16. NOW THEREFORE, this order is issued permitting the institution i.e. University College of Education, Sri Krishnadevaraya University, Ananthpur, Andhra Pradesh-515003 for continuation of recognition for B.Ed. Programme for two years duration with an annual intake of (2 basic units) of 50 students each subject to fulfillment of the following conditions: -
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 17. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 18. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 19. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-

teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities:
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **20**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 21. The institution shall make available the list of students admitted on its official website.
- 22. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
