WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely Deccan College of Education, Pamulaparthy Village, Mdl Wargal, Medak District-502279, Andhra Pradesh (Now Telangana) run by Almas Educational Society, Medak District, Andhra Pradesh (Now Telangana) vide order no. F.SRO/NCTE/B.Ed./2008-2009/4444 on 30.08.2008 for conducting (B.Ed.) course of one year duration from the academic session 2008-2009 with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 28.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the institution has submitted a written representation dt. 10.12.2015 for sanction of one unit of 50 students for B.Ed. college.The SRC in its 301st meeting held on 05th -06th February 2016 considered the matter and decided to issue a Corrigendum to the institution. Accordingly, a Corrigendum order no. F.No.SRO/NCTE/APSO7746/B.Ed./TS/2017-18/94686dated06.09.2017 was issued to the institution for conducting B.Ed. programme of two years duration with an annual intake of 50 students of one basic unit from the academic session 2016-2017.
- 4. AND WHEREAS, the SRC in its 369<sup>th</sup> Meeting held on 28<sup>th</sup> January, 2019 considered the matter and decided to issue Show Cause Notice to the institution. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 21.02.2019. The institution has not submitted any reply to the Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 381<sup>st</sup>Meeting held on 31<sup>st</sup>Oct & 1<sup>st</sup> Nov, 2019 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 14.11.2019. The institution has submitted its reply on 30.12.2019.
- **6. AND WHEREAS,** the SRC in its 409<sup>th</sup> Meeting held on 29<sup>th</sup> &30<sup>th</sup>March, 2022 considered the matter and decided to withdrawal the recognition. Accordingly, as per decision of SRC, a Withdrawal order was issued to the institution on 20.04.2022 vide order no. F.SRO/NCTE/APSO7746/B.Ed./TS/2022/131594-131598.
- 7. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No. 89-273/E-284664/2022 Appeal/11<sup>th</sup> Meeting, 2022, APPLSRC202214374 dated 11.01.2023 rejects the appeal and confirmed withdrawal order dated 20.04.2022.

- 8. AND WHEREAS, the institution had filed Writ Petition before the Hon'ble High Court of Delhi at New Delhi bearing W.P (C) 7199 of 2023 title Deccan College of Education vs. NCTE & Anr. whereby the Hon'ble High Court vide order dt. 26.07.2023 has directed that:-
  - "22.Taking into consideration the above submissions, this court finds it appropriate to set aside the order of withdrawal passed through 304<sup>th</sup> meeting of the Western Regional Committee held on 02<sup>nd</sup> to 04<sup>th</sup> April 2019 and the order of the Appellate Authority dated 22.05.2019. However, setting aside of the order of withdrawal and the order of the Appellate Authority would not revive the recognition of the petitioner-institution. The recognition of the petitioner-institution would remain subject to further decision to taken by concerned SRC.
  - 23. The petitioner-institution is directed to appear before the concern SRC along with all the relevant documents within a period of 15 days from the date of receipt of copy of this order.
  - 24. The Concerned SRC is directed to decide the case of the petitioner institution afresh in accordance with law and if necessary shall conduct fresh inspection. If the SRC finds that the petitioner-institutions is fulfilling the necessary requirements, in accordance with the applicable regulations, the order of restoring the recognition of the petitioner-institution be passed and the said exercise be done within a period of 30 days from the date of receipt of copy of this order.
  - 25. With the aforesaid observations, the instant petition stands disposed of alongwith the pending application."
- **9. AND WHEREAS,** the institution has filed a CM Appl. No. 39815/2023 in W.P (C) 7199 of 2023 and the Hon'ble High Court Delhi order dated 04.08.2023 has directed that:-
  - "3. On perusal of the record, the said inadvertent errors appear to be correct and the same be rectified accordingly.
  - 4. In view of the aforesaid, paragraph no. 22 of order dated 26.07.2023 passed in W.P.(C) 7199/2023, now reads as under:- "22. Taking into consideration the above submissions, this court finds it appropriate to set aside the order of withdrawal passed through 409th Meeting of the Southern Regional Committee held on 29th 30th March, 2022 and the order of the Appellate Authority dated 11.01.2023. However, setting aside of the order of withdrawal and the order of the Appellate Authority would not revive the recognition of the petitioner-institution. The recognition of the petitioner-institution would remain subject to further decision to be taken by the concerned SRC.
  - 5. The application is accordingly disposed of."
  - 10. AND WHEREAS, the SRC in its 428<sup>th</sup> Meeting held on 25<sup>th</sup> August, 2023 considered the matter and decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

In obedience of Hon'ble High Court of Delhi at New Delhi order dated 26.07.2023 passed in W.P (C) No. 7199 of 2023 titled as Deccan College of Education vs. NCTE

& anr. the institute submitted the documents on 24.08.2023 and on the perusal of the same, the Committee decided that continuation order be issued to the Institution Deccan College of Education, Survey No. 489, Pamulaparthy, Gram Panchayath, Wargal Mandal, Medak District-502279, Telangana for B.Ed. programme for 1 basic unit of 50 students.

- NOW THEREFORE, this order is issued permitting the institutioni.e.Deccan 11. College of Education, Survey No. 489/A, Pamulaparthy, Gram Panchayath, Wargal Mandal, (Now Markook), Medak District-502279, (Now Siddipet) Telangana for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -
  - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - The institution shall make admissions only after it obtains affiliation from the III. examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - The institution shall ensure that the required number of academic staff duly IV. approved by affiliating body for conducting the course should always remain in position.
- Further, the institution is required to fulfil all such other requirements as may be 12. prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- The institution shall submit to the Regional Committee as Self Appraisal Report at 13. the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter - alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land. building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and nonteaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
  - Sanctioned programme(s) along with annual intake in the institution: a.
  - Name of faculty and staff in full as mentioned in school certificate along with b. their qualifications, scale of pay and photograph.
  - Name of faculty members who left of joined during the last, quarter: C.
  - Name of Students admitted during the current session along with qualification, d. Percentage of marks in the qualifying examination and in the entrance test, if Meury anv. date of admission, etc.
  - Fee charged from students. e.

- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 16. The institution shall make available the list of students admitted on its official website.
- 17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
