### TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 WITHDRAWAL ORDER

WHEREAS, recognition u/s 15 (3)(a) Act of NCTE, 1993 was granted to the institution namely. NSS Training College, Ottaplam, Palakkad District, Kerala - 679101 vide order no. F.SRO/NCTE/KL/2009-2010/16274 dt. 30.10.2009 for conducting M.Ed. course of one year duration with an annual intake of 25 (twenty-five) students from the academic session 2009-2010.

- 2. AND WHEREAS, the consequence upon the notification of the National Council for Teacher Education (Amendment) Regulation, 2010 on dt. 26.07.2010 the intake of existing 25 students in M.Ed. course was increased from 25 to 35 students vide SRC, NCTE order dt. 20.09.2010.
- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 21.01.2015 for its willingness of two units in M.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 26.05.2015 for conducting M.Ed. course of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-16.
- AND WHEREAS, the SRC in its 388th Meeting held on 14th & 15th September, 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the documents/VT report not accompanied with the requisite documents. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution dt. 16.04.2015. The institution did not submit any reply to Show Cause Notice.
- AND WHEREAS, the SRC in its 412th Meeting held on 05th & 06th July, 2022 has 5. considered the matter and decided to issue last reminder (Letter) to the institution. Accordingly, as per the decision of SRC a last reminder (Letter) was issued to the institution on 21.07.2022. The institution did not submit any reply to last reminder (Letter).
- AND WHEREAS, the SRC in its 415<sup>th</sup> Meeting held on 03<sup>rd</sup> & 04<sup>th</sup> November, 2022, again considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The institution failed to submit reply to the Last Reminder Letter dated 21.07.2022.

Hence the recognition granted N.S.S. Training College, Ottapalam, Palakkad District, Kerala-679101 for M.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e., 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn."

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdrawing the recognition granted to N.S.S. Training College, Ottapalam, Palakkad District, Kerala-679101 run by Nair Service Society, Ottapalam, Palakkad District, Kerala-679101 for conducting M.Ed. programme of two years duration with an annual intake of 50 students (1 basic unit). No fresh admissions are permitted now onwards. However, if any student is pursuing M.Ed. programme is allowed to continue till, they complete the course.
- 8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

- (8. इसके अलावा, संस्था और संबद्ध निकाय को एनसीटीई अधिनियम की धारा 17(4) के निम्नलिखित प्रावधानों के बारे में सूचित किया जाता है: -
  - "यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमित प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")
- 9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
