WHEREAS, the recognition was granted to the institution namely, S.S.E.Ts Mahila Shiksha Mahavidyalaya, Shivabasav Nagar, Belgaum – 590010, Karnataka vide order no. F.SRO/NCTE/B.Ed/2004-2005/8934 dt. 30.11.2004 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, the request of institution for change of name of B.Ed. College from "Sri Siddarameshwar Education Trust's College of Education for Women" to "Sri Siddarameshwar Education Trust's Chandragiri College of Education for Women" was considered by SRC in its 184<sup>th</sup> Meeting held on 26<sup>th</sup> & 27<sup>th</sup> October 2009. Accordingly, a letter was issued to the institution on 04.02.2010.
- 3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 29.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 27.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of 100 students (Two units) from the academic session 2015-2016.
- 4. AND WHEREAS, a Corrigendum vide order no. F.No.SRO/NCTE/APSO2019/B.Ed. /KA/2015-2016/69885 dt. 15.07.2015 SRC, NCTE hereby grants recognition to Shri Siddarameshwar Education Trust's Chandragiri College of Education for Women, Shivabasavanagar, Belgaum, Karnataka-590010 for conducting B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16.
- 5. AND WHEREAS, the matter regarding compliance by the institution of the condition of the revised recognition order, was placed before the SRC in its 381<sup>st</sup> Meeting held on 31<sup>st</sup> Oct & 01<sup>st</sup> Nov, 2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per decision of SRC a First Show Cause Notice was issued to the institution on 08.11.2019. The institution has submitted reply of First Show Cause Notice on 28.11.2019.
- **6. AND WHEREAS,** the SRC in its 401<sup>st</sup> Meeting held on 11<sup>th</sup> & 12<sup>th</sup> August, 2021. The matter was considered and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 31.08.2021). The institution did not submit any reply to Final Show Cause Notice.
- 7. AND WHEREAS, the SRC in its 405<sup>th</sup> Meeting held on 13<sup>th</sup> & 14<sup>th</sup> December, 2021 considered the matter and decided to issue Withdrawal order. Accordingly, as per the decision of SRC Withdrawal order was issued to the institution vide order no. F.SRO/NCTE/APS02019/B.Ed./{KA}/2021/129840 dated 07.01.202.

- **8. AND WHEREAS,** aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-45/E-240744/2022 Appeal/4<sup>th</sup> Meeting, 2022 APPLSRC202214270 dt. 26.05.2022 appeal confirm the order.
- **9. AND WHEREAS**, the institution has filed W.P.(C) 10567/2022 before the Hon'ble High Court of Delhi at New Delhi in respect the SSETS Chandragiri College of Education for Women B.Ed. vs NCTE and ANR whereby the Hon'ble High Court has directed that:-
  - 11. As the said documents were also placed on record before the Appellate Committee but were not taken into consideration, in the interest of justice and in light of the position taken by co-ordinate benches of this Court, the order dated 26th May, 2022 passed by the Appellate Authority is set-aside, and the matter is remanded back to the Appellate Authority, which shall now decide the same, taking into consideration subsequent developments, and in particular, the documents which were enclosed with the appeal report by Petitioner-institute, within a period of two weeks from the date uploading of this order in accordance with law."
- **10. AND WHEREAS,** the SRC in its 413<sup>th</sup> Meeting held on 22<sup>nd</sup> & 23<sup>rd</sup> August, 2022 has considered the matter and decided to issue a letter. Accordingly, as per the decision of SRC a letter was issued to the institution on 05.09.2022. The institution has submitted a written representation with documents dt. 22.11.2022.
- 11. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-45/E-240744/2022 Appeal/4<sup>th</sup> Meeting, 2022 APPLSRC202214270 dt. 13.02.2023 appeal remand back the case. The institution has submitted reply of appeal remand back case dt. 21.02.2023.
- 12. AND WHEREAS, the SRC in its 422<sup>nd</sup> meeting held on 02<sup>nd</sup> & 03<sup>rd</sup> March 2023 considered the matter and the committee decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 05.04.2023. The institution has submitted reply of Final Show Cause Notice received on 11.04.2023.
- **13. AND WHEREAS,** the SRC in its 425<sup>th</sup> meeting held on 18<sup>th</sup> May, 2023 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC a withdrawal order no. F.SRC/NCTE/APS02019/B.Ed/KA /2023/14255-60 dated 31.05.2023 was issued to the institution.
- **14. AND WHEREAS,** aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-108/E-306686/2023 Appeal/9<sup>th</sup> Meeting, 2023 APPLSRC202314621 dt. 12.09.2023 appeal remand back the case to the SRC. The institution has submitted reply vide letter dated 27.09.2023 to appeal remand back case.
- **15. AND WHEREAS**, the SRC in its 429<sup>th</sup> Meeting held on 11<sup>th</sup> October, 2023 has considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made:-

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Shri Siddarameshwar Education Trust's Chandragiri College of Education for Women, CTS No. 10625, Wadr No. 47, Shivabasav Nagar, Belgaum, Karnataka-590010 for B.Ed. programme for 2 basic units of 50 students each."

- NOW THEREFORE, this order is issued permitting the institution i.e., Shri Siddarameshwar Education Trust's Chandragiri College of Education for Women, CTS No. 10625, Wadr No. 47, Shivabasav Nagar, Belgaum, Karnataka-590010 for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 50 students each subject to fulfilment of the following conditions: -
  - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - The institution shall make admissions only after it obtains affiliation from the III. examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - The institution shall ensure that the required number of academic staff duly approved IV. by affiliating body for conducting the course should always remain in position.
- Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain its Website with hyperlink to the Council and the Southern 19. Regional Committee, covering, inter - alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
  - Sanctioned programme(s) along with annual intake in the institution: a.
  - Name of faculty and staff in full as mentioned in school certificate along with their b. qualifications, scale of pay and photograph.
  - C. Name of faculty members who left of joined during the last, quarter:
- Name of Students admitted during the current session along with qualification. d. Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc. Menny
- e. Fee charged from students.
- Available infrastructural facilities.

g. Facilities added during the last quarter.

- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 20. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 21. The institution shall make available the list of students admitted on its official website.
- 22. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
