WHEREAS, the recognition was granted to the institution namely, Royal College of Education, Uttarahalli Main Road, Bangalore-560061, Karnataka vide SRC order no. FF.SRO/NCTE/B.Ed/2004-2005/9216 dt. 09.12.2004 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 29.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 27.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (Two units) from the academic session 2015-2016.
- AND WHEREAS, the SRC in its 315th meeting held on 17th 18th June, 2016 has 3. considered the matter and decided as under:-
 - 1. "Land document is in order.
 - 2. BP is not legible. Designation of approving authority is not clear.
 - 3. BCC, LUC, EC, latest approved faculty list and FDRs are not given.
 - 4. Application for permission to shift B.Ed (2 units) is there. But inspection fee has not been paid.
 - 5. Collect fee and cause inspection
 - 6. Ask VT to collect all relevant documents."
- AND WHEREAS, as per the decision of SRC a letter was issued to the institution on 12.07.2016. The status of issuance of SCN/FSCN was considered by the Sub- Committee constituted by the SRC in its meeting held on 22nd Oct., 2019. The Sub-Committee noted that institutions have not submitted requisite documents or only part reply has been submitted. The Sub-Committee decided to issue SCN. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 24.10.2019. The institution has not submitted reply to the Show Cause Notice.
- AND WHEREAS, the SRC in its 381st meeting held on 31st October 01st November, 2019 and 387th meeting held on 24th - 25th August, 2020 decided that SCN be issued in all such matters which have not complied with the conditions mentioned in the RPRO. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 07.09.2020. The institution has not submitted reply to the Final Show Cause Notice.
- AND WHEREAS, the SRC in its 393rd Meeting held on 05th 06th January, 2021 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC a withdrawal order no. F.SRC/NCTE/ASPO2415/B, Ed/2021/122684-2690 dated 08.01.2021 was issued to the institution.

- 7. **AND WHEREAS,** aggrieved by the withdrawal order, the institution preferred an appeal to NCTE-Hqrs. The Appellate Authority in its vide order no. F.No. 89-72/E-177398/2021 Appeal/11th Mtg.-2021/28th May, 2021 dated 02.06.2021 the Council hereby confirms the Orders appealed/against.
- **8. AND WHEREAS,** the SRC in its 400th meeting held on 13th 14th July, 2021 has considered the matter and decided to confirming the withdrawal order. The institution has filed Writ Petition before Hon'ble High Court of Karnataka bearing WP. © No. 23621 of 2021 titled as Royal College of Education Versus National Council for Teacher Education & Anr. Whereby the Hon'ble High Court vide order dated 21.06.2022 has directed that:-

"The learned counsel for respondent No.1 upon instructions submit that respondent No.1 has no objection to inspect the premises of the petitioner-Institution and if it is found that the petitioner has necessary infrastructure, due recognition will be granted and in this regard the petitioner is required to give a representation to respondent No.1. The petitioner has no objection for the same.

The petitioner – Institution is given liberty to give appropriate representation to respondent No.1.

The respondent No.1 upon receipt of such representation within a period of six weeks there after shall consider the same in accordance with law, inspect the premises of the petitioner — Institution and take appropriate decision without relying upon the impugned order dated 08.01.2021 vide Annexure- E to the writ petition."

- 9. AND WHEREAS, the institution vide letter dated 11.08.2022 submitted written representation. The SRC in its 413th meeting held on 22nd 23rd August, 2022 considered the matter and decided to constitute VT. Accordingly, as per the decision of SRC VT was constituted. The VT members visited (virtual) the institution on 19.07.2023. The inspection report has been received on 20.07.2023 through online.
- **10. AND WHEREAS,** the SRC in its 427th meeting held on 20th July, 2023 considered the VT report and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 26.07,2023. The institution has submitted vide letter dated 08.10.2023 reply to Show Cause Notice.
- 11. AND WHEREAS, the SRC in its 429th meeting held on 11th October, 2023 considered the matter and decided as follows:-

"The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee on perusal of the reply submitted by the institution namely Royal College of Education decided that shifting of premises be permitted to the institution at new address i.e. Survey No. 1/2, 1/3, Mallapuram, Nelamangala, Bangalore Rural District-560061, Karnataka. The Committee also decided that

continuation order be issued to the Institution for **B.Ed.** programme for **2 basic units** of **50 students each.**"

- 12. NOW THEREFORE, this order is issued permitting the institution i.e. Royal College of Education, Uttarahalli Main Road, Bangalore-560061, Karnataka to shift its building at new address at Survey No. 1/2, 1/3, Mallapuram, Nelamangala, Bangalore Rural District-560061, Karnataka. Further as per the decision of the SRC, an order for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (two units) of 50 students each subject to fulfilment of the following conditions: -
 - 1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **13.** Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 14. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 15. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application

- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **16**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 17. The institution shall make available the list of students admitted on its official website.
- 18. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
