CONTINUATION ORDER

WHEREAS, the recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely **Koviloor Andavar College of Physical Education & Sports Sciecn, Koviloor, Sivagangai District – 630307, Tamilnadu** vide order No. F.SRO/NCTE/M.P.Ed./2008-09/4113 dated 22.08.2008 for conducting **M.P.Ed. Course** of two-years duration with an annual intake of 30 students from the academic session 2008-09.

2. **AND WHEREAS**, the institution has submitted its written representation on 06.06.2014. The SRC in its 270th meeting held on 13th July 2014 considered the matter and all relevant documents and decided to cause inspection to examine whether the institution fulfils all the requirements as per the norms, for the proposed increase in intake of M.P. Ed. Course, subject to the condition that the deficiencies, if any, were duly rectified by the institution, as per the norms.

3. **AND WHEREAS**, the SRC in its 284th Meeting held on 09th – 10th April 2015, considered the VT report and all other relevant documents and it has decided to issue Show Cause Notice was issued on 27.04.2015. The institution has not submitted any reply. the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

4. **AND WHEREAS**, the matter was further considered by the SRC in its 380th meeting and decided to issue Final Show Cause Notice to all such institution where reply to FSCN has not been submitted by the Institution. Accordingly, a final show cause notice was sent on 21.11.2019. The institution has submitted its reply on 11.12.2019.

5. **AND WHEREAS**, the SRC in its 384th meeting held on 12th & 13th February, 2020 the Committee considered and decided to withdraw the recognition. Accordingly, as per the decision Withdrawal Order was issued vide order no.:F.SRC/NCTE/APSO9258/M.P.Ed. /116077-116083 dated 19.03.2020.

6. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No. 89-105/E-158607/2020 Appeal/24th Mtg.-2020/23rd October, 2020 dated 19.11.2020 appeal remand back the Order appealed against. The institution has not submitted reply to the appeal remand back case.

7. **AND WHEREAS**, the SRC in its 397th meeting held on 25 – 26 March 2021 has considered the matter and the Committee decided to issue a Final Show Cause Notice. Accordingly, a Final Show Cause Notice issued to the institution on 12.04.2021. The institution has submitted a reply in response to the Final Show Cause Notice on 16.04.2021.

8. **AND WHEREAS**, the SRC in its 401st meeting held on 11th & 12th August 2021 considered the matter and committee decided to withdraw the recognition. Accordingly, as per the decision of

SRC a withdrawal order no. F.SRO/NCTE/APS09258/M.P.Ed./TN/2021 /128444 dated 28.08.2021 was issued to the institution.

9. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-301/E-214850/2021 Appeal/4th Meeting, 2022 APPLSRC202114166 dated 26.05.2022 appeal rejected and the impugned withdrawal order is confirmed.

10. **AND WHEREAS**, the institution has filed Writ Petition before Hon'ble High Court of Delhi bearing W.P (C) No. 11956/2022 & CM APPL. 35721/2022 titled as St Koviloor Andavar College of Physical Education and Sports Science Versus National Council for Teacher Education.

11. **AND WHEREAS**, in compliance of court order, the SRC in its 414th meeting held on 26th & 27th September 2022 considered the matter and Committee decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 12.10.2022. the institution has submitted reply of Final Show Cause Notice vide letter dated 15.10.2022.

12. **AND WHEREAS**, the SRC in its 425th meeting held on 18th May 2023 considered the matter and Committee decided to issue Last Reminder Letter. Accordingly, as per the decision of SRC, a Last Reminder Letter was issued to the institution on 01.06.2023. The institution vide dated 27.06.2023 has submitted a reply to the Last Reminder Letter.


13. **AND WHEREAS**, the SRC in its 427th meeting held on 20th July 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Koviloor Andavar College of Physical Education & Sports Science, Survey No. 179/1-2, 180/1, North Car Street, Kovillor, Kalanivasal Village, Koviloor Panchayat, Kallai Union, Karaikudi Taluk, Sivaganga District-630307, Tamilnadu for M.P.Ed. programme - 1 basic unit of 40 students. "

14. **NOW THEREFORE**, this order is issued permitting the institution i.e. Koviloor Andavar College of Physical Education & Sports Science, Survey No. 179/1-2, 180/1, North Car Street, Kovillor, Kalanivasal Village, Koviloor Panchayat, Kallai Union, Karaikudi Taluk, Sivaganga District-630307, Tamilnadu for continuation of recognition for M.P.Ed. Programme for two-years duration with an annual intake of (1 basic unit) of 40 students subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.



- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

15. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

16. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

17. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution;
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter;
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

18. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

19. The institution shall make available the list of students admitted on its official website.


20. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.


