- (iii) Order No. F.SRO/NCTE/B.Ed-Al/2009/12523 dated 11.05.2009 for conducting B.Ed. (additional) Course of one year duration with an annual intake of 300 students which is includes the existing intake of 200 (two hundred) students from the academic session 2009-2010.
- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 23.01.2015 for B.Ed, B.Ed-Al & B.Ed.-Al Programme and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 04.08.2015 respectively for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16, the Revised Provisional Recognition Order(RPRO) was issued to the institution on 08.05.2015 respectively for conducting B.Ed-Al Programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16 & the Revised Provisional Recognition Order(RPRO) was issued to the institution on 08.05.2015 respectively for conducting B.Ed-Al Programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16

institution has not submitted the following requisite documents/VT Report accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, as per the decision of SRC, a Show Cause was issued to the institution on 08.06.2021. The institution has submitted a reply to the Show Cause Notice on 28.06.2021.

- 4. AND WHEREAS, on the basis of request made by the institution, the SRC in its 411<sup>th</sup> meeting held on 23<sup>rd</sup> to 24<sup>th</sup> May, 2022 decided to close the B.Ed. programme granted to the institution vide Order No. F.SRO/NCTE/B.Ed./2005-2006/4899 dated 23.12.2005 (File No. APSO 3020). Accordingly closure order was issued vide order no. SRC-NCTE/APSO3020/B.ED/TN/2022/132403-132407 dated 06.06.2022. Thus the institution remained with B.Ed. programme granted recognition vide Order No. F.SRO/NCTE/2007-2008/11926 dated 25.09.2007 and Order No. F.SRO/NCTE/B.Ed-Al/2009/12523 dated 11.05.2009.
- 5. AND WHEREAS, a Final Show Cause Notice was issued to the institution on 31.08.2021. The institution has submitted a reply to the Final Show Cause Notice on 22.06.2023 and the matter was finally considered in its 427<sup>th</sup> meeting held on 20<sup>th</sup> July 2023 and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Dhanlakshmi Srinivasan College of Education, Survey No.81/4E, 81/4F, 81/4G, 81/4H, 84/1, 85/1B, 85/2, 85/3A2, 85/3C, Thuraiyur Road, Alambadi Panchayat, Thuraiyur Road, Perambalur District-621212, TamilNadu for B.Ed. programme for 4 basic units of 50 students each."

- 6. NOW THEREFORE, this order is issued permitting the institution i.e. Dhanlakshmi Srinivasan College of Education, Survey No.81/4E, 81/4F, 81/4G, 81/4H, 84/1, 85/1B, 85/2, 85/3A2, 85/3C, Thuraiyur Road, Alambadi Panchayat, Thuraiyur Road, Perambalur District-621212, TamilNadu for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (4 basic units) of 50 students each subject to fulfilment of the following conditions:-
  - 1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 8. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
