WHEREAS, the recognition was granted to the institution namely S.K.A College of Education, Plot/Khasara No. 781/1, 781/2, 785/2, 786, Ponnagar Village, Aundipatti P.O. & Taluk, Theni District-625512, Tamilnadu vide SRC (NCTE) order no. F.No.SRO/NCTE/ SRCAPP1842/B.Ed/TN/2015/62199 dated 03.03.2015 for conducting B.Ed. programme of twoyear duration with an annual intake of 100 students from the academic session 2015-2016.

2. AND WHEREAS, the institution has submitted its representation along with documents received on 05.08.2016 requesting for cancellation of inspection. The SRC in its  $322^{nd}$  meeting held on  $20^{th} - 21^{st}$  October, 2016 considered the matter and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 17.11.2016. The institution has submitted reply received on 02.12.2016.

3. AND WHEREAS, the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup> – 15<sup>th</sup> September, 2020 the Committee directed the Regional Director, SRC to issued a Show Cause Notices u/s 17 of NCTE Act, 1993 to all the institutions wherein Recognition was accorded by the SRC under Regulations 2014 with the direction to submit all requisite documents coupled with latest approved Staff list from concerned affiliation bodies. In case no reply or part reply to SCN is received by the SRC office. The RD is also authorized to issue SCN in all such matters. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 24.09.2020. The institution has submitted reply received on 15.10.2020.

**4. AND WHEREAS,** the SRC in its  $395^{th}$  meeting held on  $25^{th} - 26^{th}$  February, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 16.03.2021. The institution has submitted reply received on 20.04.2021.

5. AND WHEREAS, the matter was placed before the SRC in its 400<sup>th</sup> meeting held on 13<sup>th</sup> – 14<sup>th</sup> July, 2021 and the Committee decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution S.K.A College of Education, Survey No. 781/1, 781/2,785/1 & 786, Pon Nagar, Ethakoil Road, Aundipatty, Bodithasanpatty Panchayrt, Theni District-625512, Tamilnadu for B.Ed. programme for 2 basic units of 50 students each."

NOW THEREFORE, this order is issued permitting the institution i.e. S.K.A College of Education, Survey No. 781/1, 781/2,785/1 & 786, Pon Nagar, Ethakoil Road, Aundipatty, Bodithasanpatty Panchayrt, Theni District-625512, Tamilnadu for Continuation of recognition for B.Ed. programme for two year duration (2 basic units) of 50 students each subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

8. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

9.
