#### CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely Indian College of Education, Old No.54, New No.51/2A, Katpadi-Thiruvalam Road, Opp. To VIT, Katapadi, Vellore-632014, Tamilnadu vide SRC (NCTE) order no. F.SRO/NCTE/M.Ed./2006-2007/12738 dated 09.10.2007 for (M.Ed.) course of one-year duration with an annual intake of 25 students.

2. AND WHEREAS, the enhancement of intake of 10 seats from existing 25 to 35 is permitted to Indian College of Education, Opp to VIT, Katpadi, Vellore-632014, TamilNadu vide order No.F.SRO/NCTE/2010-2011/20614 on 24.08.2010 from the session 2010-2011.

3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 05.01.2015 & for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 22.05.2015 for conducting M.Ed. programme of two years duration with an annual intake of 50 students (one unit) from the academic session 2015-16.

4. AND WHEREAS, the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup>-15<sup>th</sup> September 2020 has considered the matter was considered before the Committee and decided to issue Show Cause Notice to the institution. Accordingly, a Show Cause Notice was issued to the institution on 08.06.2021. The institution vide letter dated 07.07.2021 submitted its reply to the Show Cause Notice.

5. AND WHEREAS, the matter was placed before the SRC in its 400<sup>th</sup> meeting held on 13<sup>th</sup> – 14<sup>th</sup> July 2021 and the Committee decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Indian College of Education, Survey No. 587/2A, 588/1, 588/3A, 588/3B, 588/4, 51/2A, Ward No. 12, Katpadi-Thiruvalam Road, Opp to VIT, Vellore-632014, Tamilnadu for M.Ed. programme for 1 basic unit of 50 students".

6. NOW THEREFORE, this order is issued permitting the institution i.e. Indian College of Education, Survey No. 587/2A, 588/1, 588/3A, 588/3B, 588/4, 51/2A, Ward No. 12,

- The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint 1. account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done. 11.
- The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time. 111.
- The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) IV.
- The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

Further, the institution is required to fulfill all such other requirements as may be 7. prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

The institution shall submit to the Regional Committee as Self - Appraisal Report at the 8. end of each academic year along with the statement of annual accounts duly audited by a

- The affidavit with enclosure submitted along with application. i.

The institution shall be free to post additional relevant information if it so desires.

k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

**10**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

11. The institution shall make available the list of students admitted on its official website.

12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
