WHEREAS, the recognition was granted to the institution namely VET College of Education, S.M.V. Compound, Near E.B. Sub Station Main Road, Panagudi, Tirunelveli District, Tamilnadu-627109 run by Victor Educational Trust, Tirunelveli District, Tamilnadu vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/18930 dated 28.02.2008 for conducting secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition Order was issued to the institution on 20.03.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the institution inspection was conducted on 12.11.2016 and report was received on 15.11.2016. The SRC in its 397<sup>th</sup> Meeting held on 25<sup>th</sup> & 26<sup>th</sup> March 2021 has considered the matter and the Committee decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 08.04.2021. The institution vide letter dt. 19.04.2021 has submitted a reply in response to the Final Show Cause Notice.
- 4. AND WHEREAS, the SRC in its 399<sup>th</sup> meeting held on 15<sup>th</sup> & 16<sup>th</sup> June 2021 has considered the matter and the Committee decided to withdraw B.Ed. programme. Accordingly, as per decision of SRC a withdrawal order no. F.SRO/NCTE/APSO8461/ B.Ed./TN/2021 dt. 02.07.2021 was issued to the institution. The institution has submitted reply received on. 12.07.2021 and requested to reconsider the decision of withdraw of B.Ed. programme.
  - 5. AND WHEREAS, the matter was placed before the SRC in its 400<sup>th</sup> meeting held on 13<sup>th</sup> 14<sup>th</sup> July 2021 and the Committee decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution VET College of Education, Survey No. 2415/3A, 2415/3B1, 2416/1A, Parungudi Village, Kavalkinaru Panchayat, Radhapuram Taluk, Tirunelveli District-627109, Tamilnadu for B.Ed. programme for 2 basic units of 50 students each."

6. NOW THEREFORE, this order is issued permitting the institution i.e., VET College of Education, Survey No. 2415/3A, 2415/3B1, 2416/1A, Parungudi Village, Kavalkinaru Panchayat, Radhapuram Taluk, Tirunelveli District-627109, Tamilnadu for Continuation

of recognition for B.Ed. programme for two year duration (2 basic units) of 50 students each subject to fulfilment of the following conditions: -

 The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 8. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme (s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned.   - g. Facilities added during the last quarter.
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **10**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
