WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Sarada B.P.Ed. College Plot/Khasara No.Sy No.456/3, Medarametla Village and Post Office, Korisapadu Taluka, Prakasam District-523212, Andhra Pradesh run by St. Marrys Christian Minority Educational Society, Plot/Khasara No.456/3, Medarametla Village and Post Office, Korisapadu Taluka, Prakasam District-523212, Andhra Pradesh vide order No.F.SRO/NCTE/SRCAPP14832/B.P.Ed./AP/2016-2017/93115 dated 02.05.2017 for conducting B.P.Ed. Programme of two-years duration with an annual intake of one basic unit of 100 students (two sections of 50 students each) from the academic session 2017-2018.

- **2. AND WHEREAS**, the SRC in its 413th meeting held on 22nd 23rd August 2022 discussed the matter about the institutions who failed to submit the PAR as advised by the NCTE and directed to the Regional Director, SRC to serve a Show Cause Notice to failure of submitting the PAR to all such institutions seeking infrastructure and instructional details along with GIS location at the earliest. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 23.01.2023. The institution has submitted a reply to the Show Cause Notice on 17.06.2023.
- 3. AND WHEREAS, the SRC in its 426th meeting held on 23rd June 2023 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 03.07.2023. The institution has submitted a reply the Final Show Cause Notice on 08.08.2023.
- **4. AND WHEREAS,** the SRC in its 429th meeting held on 11th October 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Sarada B.P.Ed. College, Survey No.285, 278, 456/3A, Medarametla Gram panchayat, Korisapadu Taluka, Prakasam District-523212, Andhra Pradesh for B.P.Ed. programme for 1 basic unit of 100 students".

- 8.
