WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Brilliant Minds and Resources College (B.El.Ed.) of Education, Plot No. 16-126/A&B, Prashanth Nagar Village, Siddipet Post & Taluk, Medak District, Telangana-502103 run by Edison Educational Society, Plot No. 19-93/4, Prashanth Nagar Village, Siddipet Post & Taluk, Medak District, Telangana-502103 vide order No. F. SRO/NCTE/SRCAPP14959/B.Ed./TS/2016-2017/84086 dated 12.04.2016 for conducting B.Ed. programme of two-years duration intake of two units 50 students each from the academic session 2017-2018.

- 2. AND WHEREAS, the SRC in its 408th Meeting held on 02nd March, 2022 has taken the decision to issue Show Cause Notice to all the colleges of teacher education established even after NCTE Regulations, 2014 at the earliest in order to ascertain the compliance of NCTE Regulation, 2014. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 04.05.2023. The institution has submitted a reply of Show Cause Notice dt. 17.05.2023.
- 3. AND WHEREAS, the SRC in its 426<sup>th</sup> meeting held on 23<sup>rd</sup> June, 2023 has considered the matte decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 03.07.2023. The institution has submitted its reply vide letter dated 03.07.2023 to Final Show Cause Notice.
- 4. **AND WHEREAS**, the SRC in its 427<sup>th</sup> meeting held on 20<sup>th</sup> July 2023 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order no.F.SRC/NCTE/SRCAPP14959/B.Ed./TS/2023/142926, 30 dated 27.07.2023 was issued to the institution.
- 5. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-135/E-312732/2023 Appeal/9<sup>th</sup> Meeting, 2023 Appeal No.APPLSRC202314648 dated 12.09.2023 appeal remand back the order appealed against. The institution has submitted a reply to the Appeal Remand Back Case on 21.09.2023.
- 6. AND WHEREAS, the SRC in its 429<sup>th</sup> meeting held on 11<sup>th</sup> October 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Brilliant Minds and Resources College (B.El.Ed.) of Education, Survey No. 1381, Prashanth Nagar, Siddipet Mandal, District Medak-502103, Telangana for B.Ed. programme for 2 basic upits of 50 students each."

NOW THEREFORE, this order is issued permitting the institution i.e. Brilliant Minds and Resources College (B.El.Ed.) of Education, Survey No. 1381, Prashanth Nagar, Siddipet Mandal, District Medak-502103, Telangana for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic units) of 50 students each subject to fulfillment of the following conditions:-
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **5.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **8.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

- j. The institution shall be free to post additional relevant information if it so desires.
