WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Rural B.Ed. College, Aurad(B), Bidar District, Karnataka-585326 vide order no. F.SRO/NCTE/B.Ed./2005-2006/5289 dated 31.01.2006 for Secondary (B.Ed.) course of one year duration from the academic session 2005-2006 with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 19.06.2015 for its willingness for B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 01.07.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 Students two basic units of 50 students each from the academic session 2015-16
- 3. AND WHEREAS, a corrigendum was issued vide order no. F.SRO/NCTE/APSO2404/B.Ed./KA/2015/69883 dt. 15.07.2015 grants recognition to Rural B.Ed. College, Aurad (B), Bidar District, Karnataka 585326 for conducting B.Ed. programme of two years duration with an annual intake of 50 students for one basic unit from the academic session 2015-2016.
- 4. AND WHEREAS, the SRC in its 298<sup>th</sup> Meeting held on 08<sup>th</sup> to 10<sup>th</sup> January, 2016 has considered the matter and decided to issue a letter to the institution. Accordingly, as per the decision of SRC a letter was issued to the institution on 20.05.2016. The institution has not submitted any reply to letter.
- 5. AND WHEREAS, the matter was considered by the SRC in its 373<sup>rd</sup> Meeting held on 26<sup>th</sup> & 27<sup>th</sup> March, 2019 and the Committee decided to issue Withdraw order. Accordingly, as per the decision of SRC, Withdrawal Order vide order no. F.SRO/NCTE/APSO2404/B.Ed./KA/2019/102724-730 dt. 03.04.2019 was issued to the institution for B.Ed. programme.
- **6. AND WHEREAS,** aggrieved by the order of the SRC, the University preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.91-20<sup>th</sup>/21<sup>st</sup>Mtg./2019-Appeal/81322 dt. 02.08.2019 appeal remand back the case to SRC with a direction to consider the documents.
- 7. AND WHEREAS, the SRC in its 379<sup>th</sup> Meeting held on 21<sup>st</sup> & 22<sup>nd</sup> August, 2019 has considered the matter and decided to issue a letter to the institution. Accordingly, as per the decision of SRC a decision letter was issued to the institution on 29.08.2019. The institution has submitted a written representation regarding re-submission of the Demand Draft of balance payment of shifting fees of the institution.
- 8. AND WHEREAS, the institution has submitted a written representation regarding resubmission of the Demand Draft of balance payment of shifting fees of the institution.

9. AND WHEREAS, the inspection of institution was conducted on 06.11.2023 and the Visiting Team report was received on 09.11.2023.

- 10. AND WHEREAS, the institution vide letter dt. 17.11.2023 has submitted documents as per the direction of the inspection committee.
- 11. AND WHEREAS, the SRC in its 430<sup>th</sup> Meeting held on 01<sup>st</sup> December, 2023 has considered the matter and decided as follows: -

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee on perusal of the reply submitted by the institution namely Rural B.Ed. College decided that shifting of premises be permitted to the institution at new address i.e., Survey No. 116, Ring Road, Aurad (B) Taluq, Bidar District, Karnataka-585326. The Committee also decided that continuation order be issued to the Institution for B.Ed. programme for 1 basic unit of 50 students."

- 12. NOW THEREFORE, this order is issued permitting the institution i.e., Rural B.Ed. College, Aurad(B), Bidar District, Karnataka-585326 to shift its building at new address at Survey No. 116, Ring Road, Aurad (B) Taluq, Bidar District, Karnataka-585326. Further as per the decision of the SRC, an order for continuation of recognition for B.Ed. course of two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 13. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 14. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 15. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:

- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 16. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 17. The institution shall make available the list of students admitted on its official website.
- 18. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
