WHEREAS, the recognition was granted to the institution namely, Institute of Advanced Study in Education (IASE), Kakatiya University, Vidyaranyapuri, Warangal-506009, Andhra Pradesh (Now Telangana) vide order dated 18.10.2002 for conducting M.Ed. course with an annual intake of 20 students. Based on the Performance appraisal report (PAR) the intake was fixed as 20 vide order dated 01.09.2003 for the session 2003-2004. Based on the Performance appraisal report (PAR) the intake of students was fixed as 25 vide order dated 15.12.2004 for the session 2004-2005.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 19.01.2015 for its willingness for M.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 29.05.2015 for conducting M.Ed. course of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-16.
- 3. AND WHEREAS, the institution has submitted its written representation on 03.08.2015 along with staff list.
- 4. AND WHEREAS, the Committee considered the matter/written representation in its 292nd Meeting held on 29th & 30th September, 2015 and decided to issue letter to the institution. According, as per the decision of SRC a letter was issued to the institution on 05.12.2015 for submission of requisite documents.
- 5. AND WHEREAS, the SRC in its 381st Meeting held on 31st October & 01st November, 2019 considered the matter and decided to issue First Show Cause Notice in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents. Accordingly, as per the decision of SRC First Show Cause Notice was issued to the institution on 25.11.2019.
- 6. AND WHEREAS, the SRC in its 402nd Meeting held on 13th -14th September 2021 again considered the matter and decided to issue last reminder letter to the institution. Accordingly, as per decision of SRC a last reminder letter was issued to the institution on 07.10.2021. The institution has not submitted reply to the last reminder letter.
- 7. **AND WHEREAS**, the SRC in its 409th meeting held on 29th 30th March 2022 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order vide order no. F.SRO/NCTE/APS02895/M.Ed./TS/2022/131432-131435 was issued to the institution on 13.04.2022.
- 8. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-137/E-255383/2022 Appeal/7th Meeting, 2022 Appeal No. APPLSRC202214366 dated 19.10.2022 remand back the case to SRC with a direction to SRC to consider the documents submitted in

- 9. AND WHEREAS, the SRC in its 415th meeting held on 03rd & 04th November, 2022 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 23.11.2022. The institution has submitted reply of Final Show Cause Notice vide letter dt. 07.01.2023.
- 10. AND WHEREAS, the SRC in its 419th meeting held on 13th January, 2023 has considered the matter and decided to issue letter. Accordingly, as per the decision of SRC a letter was issued to the institution on 27.01.2023. The institution has submitted reply of last reminder (Letter) vide letter dated 06.02.2023.
- 11. AND WHEREAS, the SRC in its 422nd meeting held on 02nd & 03rd March, 2023 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC a withdrawal order no. F.SRC/NCTE/APS02895/M.Ed./TS/2023/141511-141515 dated 23.03.2023 was issued to the institution.
- 12. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-95/E-304484/2023 Appeal/7th Meeting, 2023 Appeal No.APPLSRC202314609 dated 13.07.2023 has remand back the case to SRC with a directed to consider the documents submitted in appeal. The institution vide letter dated 15.07.2023 has submitted reply to the appeal remand back order.
- 13. AND WHEREAS, the SRC in its 430th Meeting held on 01st December, 2023 has considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made:-

The Committee on the perusal of the reply submitted by the institution, decided that the Continuation order be issued to the Institution Institute of Advanced Study in Education (IASE), Kakatiya University, Vidyaranyapuri, Warangal-506009 Telangana for M.Ed. programme for 1 basic unit of 50 students."

- 14. NOW THEREFORE, this order is issued permitting the institution i.e., Institute of Advanced Study in Education (IASE), Kakatiya University, Vidyaranyapuri, Warangal-506009 Telangana for Continuation of recognition for M.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions:
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 15. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 16. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 17. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 18. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 19. The institution shall make available the list of students admitted on its official website.
- 12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
