CONTINUATION ORDER**

WHEREAS, the recognition was granted to the institution namely, University College of Physical Education, Yellandu Cross Road, Khamman Village and Post Office, Khamman Taluk and Town, Khamman District, Andhra Pradesh-507002 (Now Telangana) vide order no. F.SRO/SRCAPP197/B.P.Ed./AP/2015-16/65923 dt. 30.05.2015 for conducting B.P.Ed. programme of two years duration with 100 students (one unit) two section of 50 students each from the academic session 2015-2016.

2. AND WHEREAS, the Southern Regional Committee (SRC) in its 418th meeting held on 16th December, 2022 discussed the matter about the TEIs/Departments in the Universities and the Govt. colleges of Teacher Education to verify the compliance of 2014 Regulations and advised to the Regional Director SRC to send a Show Cause Notice to all the TEIs/Departments in the Universities and the Govt. colleges of Teacher Education in the jurisdictional area of SRC so as to verify the compliance of 2014 Regulations for all the Teacher Education programmes which they are offering. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 12.01.2023. The institution did not submit any reply to Show Cause Notice.

3. AND WHEREAS, the SRC in its 423rd Meeting held on 12th April, 2023 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 01.05.2023. The institution has submitted reply of Final Show Cause Notice on 15.05.2023.

4. AND WHEREAS, the SRC in its 426th Meeting held on 23rd June, 2023 has considered the matter and decided to issue a last reminder Letter to the institution. Accordingly, as per the decision of SRC last reminder Letter was issued to the institution on 12.07.2023. The institution has submitted reply of last reminder Letter on 10.08.2023.

5. AND WHEREAS, the SRC in its 430th Meeting held on 1st December, 2023 has considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made:-

The Committee on the perusal of the reply submitted by the institution, decided that the Continuation order be issued to the Institution University College of Physical Education, Survey no. 221 & 222 Yellandu Cross Road, Khamman Village and Post Office, Khammam Taluk and Town, Khammam District, Telangana-507002 for B.P.Ed. programme for 1 basic unit of 100 students."

6. **NOW THEREFORE**, this order is issued permitting the institution i.e., **University College of Physical Education, Survey no. 221 & 222 Yellandu Cross Road, Khammam Village and Post Office, Khammam Taluk and Town, Khammam District, Telangana-507002** for Continuation of recognition for **B.P.Ed. programme** of two years duration with an annual intake of **1 basic unit of 100 students (2 Section of 50 students each)** subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

7. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

8. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.



10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

11. The institution shall make available the list of students admitted on its official website.


12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
