WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Indhira College of Education, Pandur, Thiruvallur Taluk, District-631203, Tamilnadu vide order No. F. TN/SEC/SRO/NCTE/2005-2006/4195 dated 02.09.2005 for conducting Secondary (B.Ed.) Course of one-year duration with an annual intake of 100 students from the academic session 2006-07.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 02.03.2015 for its willingness & adherence of provisions of new Regulations. A Revised Provisional Recognition Order (RPRO) was issued to the institution on12.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 has considered the matter and decided to issue a Show Cause notice. Accordingly, a Show Cause Notice was issued to the institution on 21.02.2019. The management of the institution vide letter dated 13.03.2019 & 24.08.2019 respectively has submitted a replies in response to the Show Cause Notice.
- **4. AND WHEREAS,** the SRC in its 380th meeting held on 18th 19th September 2019 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 26.09.2019. The management of the institution vide letter dated 29.10.2019 has submitted a reply in response to the Final Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 405th meeting held on 13th -14th December, 2021 has considered the matter and decided to withdraw the recognition of the institution. Accordingly, Withdrawal Order No.SRO/NCTE/APS06342/B.Ed./TN /2021/129838 was issued to the institution on 07.01.2022.
- 6. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-175/E-258506/2022 Appeal/8th Meeting, 2022 Appeal No.APPLSRC20221 4307(B.Ed.) and Order No.89-176/E-258506/2022 Appeal/8th Meeting, 2022 Appeal No.APPLSRC202214308 (M.Ed.) dated 16.11.2022 appeal remand back the order
