WHEREAS, recognition u/s 14 (3) (a) was granted to the institution namely Sri Parshwanath College of Education for Women, Allijally P.O., Channagiri, Davanagere -577213. Karnataka vide order No. F.SRO/NCTE/B.Ed/2004-2005/9226 dated 09.12.2004 for conducting B.Ed. course of one year duration from the academic session 2004-2005 with an annual intake of 100 students.

- 2 AND WHEREAS, the SRC in its 193rd meeting held on 21st - 22rd June, 2010 has considered the VT report and decided to withdraw the recognition order. Accordingly, as per the decision of SRC a withdrawal no. F.SRO/NCTE/2010-2011/20211 dated 03.08.2010 was issued to the institution.
- AND WHEREAS, the institution approached the Hon'ble High Court of Karnataka in W.P. 2113 of 2010 and passed judgement on 19.01.2011 which states as follows:-
 - "...The petitioner is permitted to file objections / explanation within a period of three weeks and if so done, the respondent NCTE is directed to consider the same and pass orders, in accordance with law."
- AND WHEREAS, the institution has submitted written representation on 08.02.2011. The SRC in its 201st meeting held on 22nd - 23nd February, 2011 has considered matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 25.03.2011.
- AND WHEREAS, the SRC in its 233rd meeting held on 26th 28th September, 2012 5 considered the matter and decided to confirm the withdrawal order. Accordingly, as per the decision of SRC a withdraw order no. F.No. APS02330 - 2200/B.Ed-D.Ed/KA/2012-13/47368 dated 21.11.2012 was issued to the institution.
- AND WHEREAS, the SRC in its 240th meeting, the above matter was placed before the SRC in its 257th meeting held during 20 - 22 December, 2013 wherein the Committee decided as under:-

"According to the High Court order, the institution had to remove the deficiencies within 6 months and establish the building within one year. In the meanwhile, we were required to postpone enforcement of our withdrawal order accordingly. Issue order for extension of recognition for B.Ed. and D.Ed. for the academic year 2013-14. Resubmit the case on 1st March, 2014."

- 7. AND WHEREAS, the SRC in its 268th meeting held on 04th 05th June, 2014 considered the matter, decided that as per the Hon'ble High Court order dated 27/06/2013, the one year extension of recognition given as per the High Court direction has lapsed. Our earlier order about withdrawal of recognition will be automatically revived. The Institution will be deemed to have been closed with effect from 2014-15. Accordingly, the institution, the University and SCERT should be informed. Accordingly, a letter was issued to the institution SCERT and to the University on 07.08.2014.
- 8. AND WHEREAS, the institution has submitted its written representation on 01.12.2014 stating as follows:-
 - "....I humble request you to permit to run Sri Parshwanatha College of Education, Ajjihalli post, Channagiri taluk, Davanagere District for another two years in rented building. In the meanwhile the construction will be completed in our premises. This college is situated in rural area and the students were coming from backward classes. There are three government degree colleges in this Taluk. Kindly permit us to run Sri Parshwanatha College of Education, Ajjihalli Post, Channagiri taluk, Davanagere district for the academic year 2014-15, 2015-16. Kindly do the needful at your end."
- 9. AND WHEREAS, aggrieved by the withdrawal order course vide order No.APS02330-2200/B.Ed.-D.Ed./KA/2012-13/47368 dated 21.11.2012 the institution preferred an appeal with NCTE Hqrs and the Appellate Authority in its order dated 05.05.2015 stated as follows:
 - "... Considering the grounds of withdrawal and submission made by the appellant the committee is of the view even if the appellant has voluntarily closed D.El.Ed course. the built-up area of 9976 sq.ft. is not adequate for B.Ed Course clause8 (13) of NCTE Regulations 2009 & clause 8(ii) of NCTE Regulations, 2014 prescribed that the built up area shall have to be increased by existing institutions to conform to the revised norms. The submission of the appellant that faculty of D.EL.Ed. College is used for B.Ed is also not convincing as faculty is to be approved by the affiliating university keeping in view the academic qualifications prescribed for faculty of a particular course. The Hon'ble court order put the onus on appellant to establish their own building within one year and provide necessary infrastructure and competent teaching staff within a period of six months. The court order also said that if deficiencies are not complied with by petitioner institution within stipulated period, the orders dated 21.11.2012 shall survive. Appeal Committee is of the view that since appellant institution has failed to establish its own building and also failed to furnish evidence of required faculty duly approved & appointed by Competent Authority, the withdrawal order dated 21.11.2012 issued by SRC shall survive to be effective from 2014-2015. In the above circumstances, the Committee concluded to confirm the withdrawal order dated 21.11.2012 issued by SRC to be effective form the academic session 2014-15.

NOW THEREFORE, the council hereby confirms the order appealed against".

10. AND WHEREAS, the SRC in its 290th meeting held during 10th & 11th July, 2015 considered the written representation of the institution (Appeal Confirm Case) and noted the matter.

11. AND WHEREAS, a Writ petition was filled in Hon'ble High Court of Karnataka with WP 60268 of 2014 where court gave the following directions wide order dt. 08.03.2017.

The order is an under:-

"These petitions are filed by the petitioners seeking for a direction to the respondents No. 1 and 2 to dispose of the appeal No. APPL2157 dated 07.11.2014 vide Annexure — D and for a direction to the respondent No. 2 to consider the representation dated 28.11.2014 and permit to admit students for the academic year 2014-15 vide Annexure-E.

- 2. The learned Counsel for respondents No. 1 and 2 has filed statement of objections along with Annexures-R1 to R6 which discloses that NCTE is not under any legal obligation to consider the representation dated 28.11.2014 at Annexure-E. In view of the order of this Court dated 01.02.2013 in writ petition Nos. 1050-1051/2013, the appeal stated to have been filed by the petitioner is also not maintainable. It is submitted that the appeal filed by the petitioners has been disposed of by the Respondent No. 1 vide F.No.89/358/2014/Appeal/2nd meeting/2015 No. 89/2014-15 dated 05.05.2015 and the copy of the said order was already sent to the petitioner.
- 3. In view of the disposal of the appeal as per Annexure-R6, the writ petitions do not survive for consideration.
- 4. Writ petitions stand dismissed as having become infructious.

Petitioners are at liberty to challenge the order passed by the Respondent No. 1 at Annexure-R6, if aggrieved."

- 12. AND WHEREAS, the SRC in its 335th meeting held on 11th 12th April, 2017 considered the court order and decided to issue a letter. Accordingly, a letter was issued to the Registrar, Kuvempu University on 21.04.2017.
- 13. AND WHEREAS, Further, a fresh Writ Petition was filed in High Court of Karnataka with WP No. 2329/2024, where the Court has directed the following vide order dated 08.08.2024:-

"In view of the aforesaid fats and circumstances and rival submissions, the respondents are directed to address the grievances of the petitioner and consider their representation dated 04.11.2023 at Annexure F and pass appropriate orders bearing in mind the material on record produced by the petitioners and in accordance with law, within the period of four weeks from the date of receipt of the copy of this order."

AND WHEREAS, the institution has submitted representation dated 03.09.2024 regarding shifting of premises along with documents. The institution has submitted Demand Draft of Rs. 1,77,000/- dated 03.09.2024 and D.D. No. 561956 from Bank of Baroda.

- 15. AND WHEREAS, the SRC in its 442nd meeting held on 05th September, 2024 considered the matter and decided to constitute online VT. The inspection was conducted on 10.03.2025 and VT report received on 12.03.2025.
- 16. AND WHEREAS, the SRC in its 457th meeting held on 04th April, 2025 has considered the matter and decided as under:-

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations:-

 The institution submitted the application shifting of premises on 03.09.2024. Inspection for verify of the infrastructural facilities was conducted on 10.03.2025. On examination of the VT report and other required documents, the committee found the case fit for shifting of premises.

The Committee on perusal of the reply submitted by the institution namely Srl Parshwanath College of Education decided that shifting of premises be permitted to the institution at new address i.e. Survey No. 123/37, Ward No. 18, Kote Road, Shivamogga, Karnataka - 577202. The Committee also decided that continuation order be issued to the Institution for B.Ed. programme for 2 basic units of 50 students each."

- 17. NOW THEREFORE, as per the decision of SRC, the institution i.e. Sri Parshwanath College of Education is permitted for shifting of institution from Ajjijally P.O., Channagiri, Davanagere 577213 to Survey No. 123/37, Ward No. 18, Kote Road, Shivamogga, Karnataka 577202 for B.Ed course with an annual intake of 100 students (two basic units). Further, as per the decision of the SRC, the institution also permitted continuation of recognition for B.Ed. programme of two years duration with an intake of (2 basic units) of 50 students each subject to following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 18. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

- 19. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 20. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 21. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 22. The institution shall make available the list of students admitted on its official website.
- 23. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
