WHEREAS, recognition u/s14 of NCTE Act, 1993 was granted to the institution namely, Yadaiah B.Ed. College, D.No.7-105, Plot No.21, Sai Enclave, Habsiguda, Nacharam Village, Uppal Mandal, Ranga Reddy District-500039, Telangana run by K.B.K. Educational Society, 1-7-630/B/2, Gemini Colony, RamNagar, Hyderabad-48, Telangana vide SRC (NCTE) order no.F.AP/B.Ed./SRO/NCTE/2004-2005/807 dated 23.02.2005 for conducting B.Ed. (Secondary) Course of one year duration with an annual intake of 100 students from the academic session 2004-2005.

- 2. AND WHEREAS, the SRC in its 217th Meeting of SRC held on 08th -09th February 2012 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision, a Withdrawal Order was issued to the institution on 06.03.2012.
- 3. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No.89-219/2012 Appeal/6th Meeting-2012 dated 17.07.2012 appeal remand back the order appealed against.
- 4. AND WHEREAS, an order No.F.No.APSO1312/B.Ed./AP/2013-14/54128 dt. 01.10.2013 is permitted to shift to new permanent premises at Yadaiah B.Ed. College, Sy No.293, at Yadgagrpally East Village, Yadgarpally Gram Panchayath, Keesara Mandal, Shameerpet Sub Division, Ranga Reddy District, Andhra Pradesh and also continues recognition till further orders.
- 5. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt.11.02.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 6. AND WHEREAS, the SRC in its 381st Meeting held on 31st October & 01st November 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, as per decision of SRC First Show Cause Notice was issued to the institution on 25.11. 2019. The institution has submitted a reply in response to the First Show Cause Notice on 13.01.2020.
- 7. AND WHEREAS, the SRC in its 408th meeting held on 02nd March 2022 considered the matter and decided to issue Final Show Cause Notice in all such matters where the institution has not submitted requisite documents. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 11.03.2022. The institution has submitted a written representation to the Final Show Cause Notice on 23.03.2022. The institution has submitted a reply to the Final Show Cause on 20.05.2022.

8. AND WHEREAS, the SRC in its 412th Meeting of SRC held on 05th – 06th July 2022 considered the matter for non-submission of compliance to Final Show Cause Notice and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 23.03.2022 & 20.05.2022. The Committee observed the reply submitted by the institution and found the following deficiencies.

- The institution did not submit the latest Faculty List along with Faculty approval letter from the Affiliating body in the prescribed NCTE format. The faculty shown appointed are not as per provisions of the NCTE Regulations, 2014.
- 2. The institution has submitted a photocopy of BCC which is not approved by the Competent Authority. The same is also not as per the prescribed Format.
- 3. The institution has not submitted the original 'Form A' towards Endowment Fund and Reserve Fund.
- 4. The size and dimension of class room etc are not mentioned in the building plan.

Hence the recognition granted to Yadaiah B.Ed. College, D.No.7-105, Plot No.21, Sai Enclave, Habsiguda, Nacharam Village, Uppal Mandal, Ranga Reddy District-500039, Telangana for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counselling / making admissions from the next academic session i.e. 2023-2024".

- 9. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted Yadaiah B.Ed. College, D.No.7-105, Plot No.21, Sai Enclave, Habsiguda, Nacharam Village, Uppal Mandal, Ranga Reddy District-500039, Telangana run by K.B.K. Educational Society, 1-7-630/B/2, Gemini Colony, RamNagar, Hyderabad-48, Telangana for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units) with effect from the end of next academic session i.e., 2023-2024. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate counselling from the academic session i.e., 2023-2024 and the institution is also not permitted to take any fresh admission of students from the academic session 2023-2024.
- **10.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

11. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
