WITHDRAWAL ORDER**

**WHEREAS**, recognition u/s14 Act of NCTE, 1993 was granted to the institution namely, **Siddhartha College of Education, Sneha Soudha, Siddhartha Nagar, A.G. Road, Vikarabad-501101, R.R. Dt., Andhra Pradesh** vide order No. F. AP/B.Ed/SRO/NCTE/2004-2005/879 dt.24.02.2005 for conducting Secondary (B.Ed.) Course of one year duration with an annual intake of 100 students.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution had consented to come under new Regulations vide a notarized affidavit dated 09.07.2015. A revised provisional recognition order was issued on 20.07.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup> – 15<sup>th</sup> September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 13.04.2021. The institution did not submit reply to the Show Cause Notice.

4. **AND WHEREAS**, the SRC in its 406<sup>th</sup> meeting held on 19<sup>th</sup> January, 2022 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 04.02.2022. The institution did not submit reply to the Final Show Cause Notice.

5. **AND WHEREAS**, the SRC in its 412<sup>st</sup> meeting held on 05<sup>th</sup> -06<sup>th</sup> July 2022 has considered the matter and the following observations were made:

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -*

(i) *The institution failed to submit reply to Final Show Cause Notice dated 04.02.2022.*

*Hence the recognition granted to **Siddhartha College of Education, Sneha Soudha, Siddhartha Nagar, A.G. Road, Vikarabad-501101, R.R. Dt., Andhra Pradesh** for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. **2023-2024**. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counseling / making admissions from the next academic session i.e. **2023-2024**."*

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Siddhartha College of Education, Sneha Soudha, Siddhartha Nagar, A.G. Road, Vikarabad-501101, R.R. Dt., Andhra Pradesh** for conducting **B.Ed. Programme** of two years duration with an annual intake of **100 students (two basic unit)** with effect from the end of next academic session i.e., **2023-2024**. Further, *on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate for counseling from the academic session i.e., 2023-2024 and the institution is also not permitted to take any fresh admission of students from the academic session 2023-2024.*

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

***"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."***

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
