**WITHDRAWAL ORDER**

**WHEREAS**, recognition u/s14 of NCTE Act, 1993 was granted to the institution namely, **Vaishnavi College of Education, H. No. 8-3-48/A/8, Near Lumbini High School, Teachers Colony, Mahaboobnagar, Andhra Pradesh-509002** run by **Vaishnavi Education Society, Mahaboobnagar, Andhra Pradesh** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2004-2005/1470 dt.24.03.2005 for conducting B.Ed. (Secondary) Course of one year duration with an annual intake of 100 students from the academic session 2004-2005 .

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt.22.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 11.05.2015 for conducting **B.Ed. programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.**

3. **AND WHEREAS**, the SRC in its 381<sup>st</sup> Meeting held on 31<sup>st</sup> October & 01<sup>st</sup> November 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, as per decision of SRC First Show Cause Notice was issued to the institution on 25.11. 2019. **The institution did not submit any reply to First Show Cause Notice.**

4. **AND WHEREAS**, the SRC in its 409<sup>th</sup> Meeting held on 29<sup>th</sup> & 30<sup>th</sup> March, 2022 considered the matter and decided to issue Final Show Cause Notice in all such matters where the institution has not submitted the following requisite documents. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 18.04.2022. The institution has not submitted reply of Final Show Cause Notice.

5. **AND WHEREAS**, the SRC in its 412<sup>th</sup> Meeting of SRC held on 05<sup>th</sup> – 06<sup>th</sup> July 2022 considered the matter for non-submission of compliance to Final Show Cause Notice and decided as under: -

*"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -*

- (i) *The institution failed to submit reply to the Final Show Cause Notice dated 18.04.2022.*

*Hence the recognition granted to **Vaishnavi College of Education, H. No. 8-3-48/A/8, Near Lumbini High School, Teachers Colony, Mahaboobnagar, Andhra Pradesh-509002** for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. **2023-2024**. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counselling / making admissions from the next academic session i.e. **2023-2024**".*

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted **Vaishnavi College of Education, H. No. 8-3-48/A/8, Near Lumbini High School, Teachers Colony, Mahaboobnagar, Andhra Pradesh-509002** run by **Vaishnavi Education Society, Mahaboobnagar, Andhra Pradesh** for conducting **B.Ed. Programme** of two years duration with an annual intake of **100 students (two basic units)** with effect from the end of the next academic session i.e., 2023-2024. Further, on *withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn.* Hence, the institution is not entitled to participate counselling from the academic session i.e., **2023-2024** and the institution is also not permitted to take any fresh admission of students from the academic session **2023-2024**.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

***"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."***

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
