## TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 WITHDRAWAL ORDER

WHEREAS, recognition u/s14 of NCTE Act, 1993 was granted to the institution namely, Vinayaka Mission's Annapoorna College pf Education, Periyaseeragapadi Post, N.H.47, Sankari Main Road, Salem-636308, TamilNadu run by Vinayaka Missions Research Foundation, Deemed University, Salem TamilNadu vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/10102 dt.09.01.2007 for conducting B.Ed. (Secondary) Course of one year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt.23.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 30.04.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, a letter dated 27.01.2021 has received from the institution requesting to issue the closure order.
- 4. AND WHEREAS, the SRC in its 412<sup>th</sup> Meeting of SRC held on 05<sup>th</sup> 06<sup>th</sup> July 2022 considered the matter and requesting to close the institution and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the Management vide dated 27.01.2021 by withdrawing the recognition granted to Vinayaka Mission's Annapoorna College of Education, Periyaseeragapadi Post, N.H.47, Sankari Main Road, Salem-636308, TamilNadu for conducting B.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting".

5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution by withdrawing recognition granted to Vinayaka Mission's Annapoorna College pf Education, Periyaseeragapadi Post, N.H.47, Sankari Main Road, Salem-636308, TamilNadu run by Vinayaka Missions Research Foundation, Deemed University, Salem TamilNadu for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units) with effect from the academic session i.e., 2023-2024 onwards as requested.

**6.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
