## TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 WITHDRAWAL ORDER

WHEREAS, the recognition u/s 14 of NCTE Act. 1993 was granted to the institution namely UK College of Education, Godumakunta, Keesara Mandal, Rangareddy District-501301, Andhra Pradesh run by Society for Helping Awakening Rural Poor Through Education, Rangareddy District, Andhra Pradesh vide order no F.SRO/NCTE/B.Ed. /2006-2007/2185 dated 01.05.2007 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 21.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 4. AND WHEREAS, the SRC in its 381st Meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents / VT report accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, as per decision of SRC First Show Cause Notice was issued to the institution on 25.11.2019. The institution has submitted reply of Show Cause Notice on 17.12.2019.
- 5. AND WHEREAS, the SRC in its  $410^{th}$  meeting held on  $25^{th}-26^{th}$  April 2022 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Notice was issued to the institution on 12.05.2022. The institution has submitted a reply to the Final Show Cause Notice on 15.06.2022.
- 6. AND WHEREAS, the SRC in its 412th Meeting held on 05th & 06th July 2022 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 15.06.2022. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The staff list submitted by the institution is not approved by the competent authority of the affiliating body for B.Ed. Programme.
- 2. The institution has not submitted the Form 'A' in original towards Endowment Fund and Reserve Fund for both programmes.
- 3. The size/dimensions of the class room etc. are not mentioned in the building plan.
- 4. The institution submitted a photocopy of the BCC which is not acceptable.

Hence the recognition granted to **UK College of Education, Godumakunta, Keesara Mandal, Rangareddy District, Telangana - 501301** for **B.Ed. course** is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. **2023-2024**. On withdrawal of recognition, the affiliation if any granted under Clause (\$1.0) of NCTE Regulation, 2014 by the

concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counselling / making admissions from the next academic session i.e. 2023-2024."

7. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of UK College of Education, Godumakunta, Keesara Mandal, Rangareddy District, Telangana - 501301 for conducting B.Ed. programme of two-year duration with an annual intake of 100 students (two basic units) for B.Ed. Programme with effect from the academic session i.e. 2023-2024 onwards. further on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate in counseling / making admissions from the academic session i.e. 2023-2024.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
