WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, Vivekananda Teacher Training Institute, Viveka Nagar, Thenkila, Puttur, Dakshina Kannada District, Karnataka -574201 run by The Puttur Education Society, Puttur, Dakshina Kannada District, Karnataka vide SRC vide order no. F.SRO/NCTE/D.Ed./2004-2005/8994 dt. 01.12.2004 for Elementary (D.Ed.) course of two and half year's duration from the academic session 2004-2005 with an annual intake of 50 students.

- AND WHEREAS, the SRC in its 210th meeting held on 22nd 23rd August, 2011 considered 2. the matter and decided to withdraw the recognition. Accordingly, as per decision of SRC a Withdrawal Order no. F.No. APS01531-D.Ed./KA/2011/30793 dated 12.10.2011 was issued to the institution.
- AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No. 89-452/2011 Appeal/1st meeting-2012 dated 15.02.2021 appeal remand back the order appealed against.
- AND WHEREAS, the SRC in its 228th meeting held on 24th 25th July, 2012 considered 4. the matter and decided to restore recognition and continue recognition. Accordingly, as per decision of SRC a restore and continue recognition order no. F.No. APS01531/D.Ed/KA/2012-13/45296 dated 16.08.02012 was issued to the institution.
- AND WHEREAS, the SRC in its 374th Meeting held on 09th & 10th April 2019 the matter 5. was considered and decided to issue Show Cause Notice to the institution. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 07.06.2019. The institution did not submit reply of Show Cause Notice.
- AND WHEREAS, the SRC in its 402nd Meeting of SRC held on 13th & 14th September 2021 and considered the matter as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 13.11.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution submitted a proforma of 1 Principal and 7 faculty signed by the Registrar, Mangalore University on 12.11.2020. The faculty strength is not enough to run B.Ed. course with 1 unit as stipulated under clause 5 of Appendix 4 of NCTE Regulations, 2014.
- 2. The institution submitted the building plan but the same is neither approved nor legible as the size of rooms, hall, library, labs etc. are not clearly legible.

- 3. The institution is running English Medium School and D.El.Ed. course, but demarcated building plan for each course has not been submitted.
- 4. Website of the institution is not functional with upload the information required under clauses 8(6), 8(14) and 10(3) of NCTE Regulations, 2014.
- 5. The institution did not submit satisfactory reply to the Show Cause Notice dt. 23.04.2019 mentioned as under: -
 - (i) It is observed from the Land records 1.82 Cents registered in favour of Society Puttur Education Society in the year 1994. Since then, the Society is running English medium School in the said premises. Meantime society's name got changed by the same is not affected in the Land Documents
 - (ii) The management obtained recognition for B.Ed. programme with 100 intake showing school as temporary accommodation. Subsequently the management also obtained recognition for D.Ed. programme again, in the same premises. The management has not made any efforts so far to acquire land and constructed building exclusively for the Teacher Education.

Hence, the Committee decided to withdraw the recognition granted to Vivekananda College of Education, Viveka Nagar, Thenkila, Puttur, Dakshina Kananda District, Karnataka-574201 for conducting B.Ed. & D.Ed. programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Vivekananda Teacher Training Institute, Viveka Nagar, Thenkila, Puttur, Dakshina Kannada District, Karnataka-574201 run by The Puttur Education Society, Puttur, Dakhina Kannada District, Karnataka-574201 for conducting D.Ed. course with an annual intake of 50 students with effect from the academic session i.e. 2021-2022 onwards.
- **8.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
