WHEREAS, the recognition was granted to the institution namely, Porukara College of Education, Gagultha Monastry's Campus, Champakkulam, Alappuzha District, Kerala-688505 vide SRC vide order no. F.KL/SEC/N/280/SRO/NCTE/2004-2005/1478 dt. 24.03.2005 for conducting Secondary (B.Ed.) course of one year duration with an annual intake of 100 (Hundred) students from the academic session 2004-2005.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 29.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 29.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units from the academic session 2015-16.
- 3. **AND WHEREAS,** the SRC in its 381st meeting held on 31st October-01st November 2019 decided that SCN be issued in all such matters which have not complied with the conditions mentioned in the RPRO. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution 07.09.2020. The institution has submitted reply on 22.09.2020.
- 4. **AND WHEREAS,** the SRC in its 397th meeting held on 25th -26th March 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 08.04.2021. The institution has submitted reply on 04.05.2021.
- **5. AND WHEREAS,** the SRC in its 402nd Meeting held on 13th & 14th September, 2021 considered the FSCN reply matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 20.05.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has submitted notarized copy of land document as 'Settlement Deed' in the name of 'Carmelate Mary of Imagulate Gagultha Monastery' which is not the name of the Trust or College.
- 2. The institution has submitted photocopy of LUC in the name of Gagulta Monastry'.
- 3. The institution has submitted photocopy of NEC in regional language.
- 4. The institution has submitted notarized copy of building plan which is not approved by the Competent Authority. The Multipurpose Hall area is not mentioned in the building plan.
- 5. The institution has not submitted the Site plan.

- 6. The institution has submitted photocopy of BCC in which date of inspection is not mentioned and the total built-up area is not sufficient for two basic units.
- 7. The institution has not submitted Form 'A' and copy of FDRs.
- 8. The survey nos. mentioned in the land document are 221/5, 221/4,221/7, 221/8 which is different from the survey nos. mentioned in LUC, Building Plan and BCC.
- 9. The Affiliating University has provided the approval for 6 faculties and other three faculties are not approved by Affiliating University, which are not sufficient for two units.

Hence, the Committee decided to withdraw the recognition granted to Porukara College of Education, Gagultha Monastry's Campus, Champakkulam, Alappuzha District-688505, Kerala for conducting B.Ed. programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Porukara College of Education, Gagultha Monastry's Campus, Champakkulam, Alappuzha District-688505, Kerala run by Mount Tabore Educational Charitable Society, Monastery Campus, Champakulam, Alappuzha District, Kerala-688505 for conducting B.Ed. course of two-years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2021-2022 onwards.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
