WITHDRAWAL ORDER

WHEREAS, recognition u/s14(3)(a) of NCTE Act, 1993 was granted to the institution namely, Malla Reddy College of Education (B.Ed.), Plot No.38, Jayabheri Park Road, Kompally Village, Quthubullapur Mandal, Ranga Reddy District-500014, Andhra Pradesh run by Mallareddy Educational Society, Hyderabad, Andhra Pradesh vide SRC (NCTE) Order No. F.SRO/NCTE/B.Ed./2007-2008/7346 dated 02.08.2007 for conducting B.Ed. Course of one year duration with an annual intake of 100 students.

- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by 2. consented to come under new Regulations vide a notarized affidavit dated 29.01.2015 and the Revised Provisional Recognition Order (RPRO) was issued to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16 on 06.05.2015.
- AND WHEREAS, the SRC in its 333rd meeting held on 24th March 2017 had considered the matter and permitting shifting of premises. Accordingly, as per the decision of SRC, an Order No.F.SRO/NCTE/APS070146/B.Ed./TS/2016-17/92738 was issued to the institution on 07.04.2017 for shifting of premises from Malla Reddy College of Education (B.Ed.), Plot No.38, Jayabheri Park Road, Kompally Village, Quthubullapur Mandal, Ranga Reddy District-500014, Andhra Pradesh to Malla Reddy College of Education (B.Ed.). Plot No.38. Javabheri Park Road, Kompally Village, Quthubullapur Mandal, Ranga Reddy District-500014, Telangana.
- AND WHEREAS, the SRC in its 381st meeting held on 31St Oct & 01st Nov, 2019 has considered the matter and the decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report accompanied with the requisite documents in response to RPRO matters issued by the SRC. Accordingly, as per the decision of SRC, a First Show Cause Notice was issued to the institution on 14.11.2019. The management of the institution has not submitted a reply to the Show Cause Notice.
- AND WHEREAS, the SRC in its 415th meeting held on 3rd 4th November 2022 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 22.11.2022. The management of the institution has submitted a written representation on 22.11.2022.
- AND WHEREAS, the SRC in its 417th Meeting of SRC held on 01st 02nd December 2022 considered the matter for non-submission of reply to Final Show Cause Notice and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act. 1993. Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

- 1. The institution failed to submit reply to the Final Show Cause Notice and dated 22.11.2022.
- 2. Further it is also observed that the institution has not filled Performance Appraisal Report (PAR)

Hence the recognition granted to Malla Reddy College of Education (B.Ed.), Plot No.38, Jayabheri Park Road, Kompally Village, Quthubullapur Mandal, Ranga Reddy District-500014, Telangana for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting".

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Malla Reddy College of Education (B.Ed.), Plot No.38, Jayabheri Park Road, Kompally Village, Quthubullapur Mandal, Ranga Reddy District-500014, Telangana run by Mallareddy Educational Society, Hyderabad-500014, Telangana for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two units) with effect from the next academic session i.e., 2023-2024.
- 8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act, 1993: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

- **9.** Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
