- The institution will ensure that Principal and Seven faculty members iv) duly approved by the affiliating University are in position for an intake of 100 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.
- Further, the recognition is subject to fulfillment of all such other requirements 4. as may be prescribed by other regulatory bodies like UGC, affiliating University / bodies, State Government etc, as applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal 5. Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain & update the Web-site as per provisions of 6. NCTE Regulations.
- If the Institution contravenes any of the above conditions or any of the 7. provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
