WHEREAS, the recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Loyola High School, Rekurthi, Malkapur Post, Karimnagar – 505451, Andhra Pradesh (Now Telangana) vide order no. F.SRO/NCTE/B.Ed./2006-2007/836 dt. 14.04.2007 for conducting B.Ed. course of one year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulation 2014, the institution has submitted an affidavit dt. 19.01.2015 for its willingness and adherence of provision of new Regulation. Thereafter, the Revised Provisional Recognition Order was issued to the institution on 31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, on the basis of request, the SRC in its 342^{nd} meeting held on 5^{th} 6^{th} July, 2017 decided for reduction of intake from 2 units to 1 unit. Accordingly, a order was issued to the institution on 21.07.2017 reduction of intake from 2 units to 1 unit.
- **4. AND WHEREAS,** the SRC in its 344th meeting held on 17th 18th August, 2017 considered the request for change of name decided to accepted change of name. Accordingly, as per the decision of SRC an order was issued to the institution on 24.08.2017 change of the institution from "Loyola High School" to "Loyola College of Education".
- **5. AND WHEREAS,** the SRC in its 405th Meeting held on 13th 14th December, 2021 considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a withdrawal order no. F.SRO/NCTE/APS07032/B.Ed./TS/2021/129775 dt. 31.12.2021 was issued to the institution.
- **6. AND WHEREAS**, aggrieved by the withdrawal order, the institution preferred an appeal to NCTE-Hqrs. The Appellate Authority in its order vide letter no. F.No. 89-83/E-246975/2022. Appeal/5th Meeting, 2022 dated 12.07.2022 the Council hereby confirms the Orders appealed/against.
- 7. **AND WHEREAS**, the matter was further considered by the SRC in its 413th meeting held on 22nd and 23rd August, 2022 and the Committee decided as follows:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made were made: -

The Committee noted the order of the Appellate Authority confirming the withdrawal order issued by the SRC, NCTE. Further the office of the Regional Director, SRC is advised to return the FDRs to the institution by following the prescribed rules and close the file and inform the respective affiliating body /University and the State Govt."

- 8. AND WHEREAS, the institution preferred a W.P.(C) No.35502/2022 before the Telangana High Court at Hyderabad and vide order dated 02.03.2023. The operative part is reproduced below:-
- "Granting liberty as sought, this writ petition is dismissed as withdrawn. Consequently, miscellaneous petitions, if any, pending in this writ petition, shall stand closed."
 - 9. AND WHEREAS, again the institution preferred a W.P.(C) No.15654/2023 before the Telangana High Court at Hyderabad and vide order dated 10.01.2024. The operative part is reproduced below:-

"Taking into consideration the specific averments made at para 10 of the affidavit filed by the petitioner in support of the present writ petition that the petitioner institution herein began offering the B.Ed. course with an intake capacity of 100 seats from the academic year 2007-2008 for the last 15 years and further taking into consideration the contents of the letter dated 07.03.2012 issued by the Tahsildar, Karimnagar, that the subject land in Sy.No.107 (25.34) acres had been in possession of Loyola High School Society Authorities and is being used by society to run all kinds of Educational Institutions had been alienated to Loyola High School since 1982 at Rekurthi, Karimnagar by the Government Order No.B5/534/82 dated 12.07.1982 and G.O.Ms.No.28 dated 06.1.1982 for building Educational Institutions and run and further duly considering the view taken by the Apex Court in its Judgment dated 12.04.2012 reported in 2012 (5) SCC Page 139 in "National Council for Teacher Education and another v. Vaishnav Institute of Technology and Management", in particular at paras 24, 25, 28 and 29 thereunder on the

point that Derecognition or withdrawal of recognition of a recognized institution is a drastic measure and it results in dislocating the students teachers and the staff, and duly considering the fact as borne on record that the 2" respondent herein duly considering the application of the petitioner society accorded approval in favour of the petitioner society vide order dated 14.04.2007 and the said Institution had been functioning since last 15 years, there shall be interim direction as prayed for in favour of the petitioner.

10. AND WHEREAS, the matter was further put for consideration in 432nd meeting held on 22nd January, 2024 were the SRC committee decided the following:-

"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations:-

In obedience of Court orders dt. 10.01.2024 passed by the Hon'ble High Court of Telangana at Hyderabad in WP. No. 15654 of 2023, the committee decided to maintain status quo until the next date of hearing."

11. AND WHEREAS, the institution sent a letter dated 08.02.2024 and 08.06.2024 requesting to revise the recognition based on the decision of 432nd meeting and has submitted the deficit documents to be considered stating that the management has made

necessary changes. Further, the institution has promised to comply with any further directions of SRC.

12. AND WHEREAS, the SRC in its 441st meeting held on 04th August, 2024 considered the court order and decided as under:-

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

In compliance of the direction of the Hon'ble High Court of Telangana, dated 10.01.2024, the Committee has decided to issue a provisional recognition order of recognition subject to the outcome of the WP. No. 15654/2023 pending before the Hon'ble High Cout of Telangana"

13. NOW THEREFORE, in pursuance of the Order of Hon'ble High Court of Telangana, dated 10.01.2024, the provisional restoration of recognition is here by accorded to the institution i.e., Loyola College of Education, Rekurthi, Malkapur Post, Karimnagar – 505451, Telangana for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students, subject to outcome of Writ Petition No. 15654 of 2023 pending before Hon'ble High Court of Telangana.
