WHEREAS, recognition u/s14 Act of NCTE, 1993 was granted to the institution namely, Akshara College of Education, Plot No. 13, Pamur Village & Post, Pamur Taluk, Prakasam District 523108. Andhra **Pradesh** vide F.SRO/SRCAPP2790/B.Ed./AP/2016/84807 dt. 02.05.2016 for conducting B.Ed. programme of two year duration with an annual intake of 50 students from the academic session 2016-2017.

- AND WHEREAS, the SRC in its 388th meeting held on 14th 15th September, 2020 considered the matter and decided to issue SCN/FSCN in all cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 12.07.2021. The institution has not submitted reply to the Show Cause Notice.
- AND WHEREAS, the SRC in its 408th meeting held on 02nd March, 2022 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 11.03.2022. The institution has not submitted reply to the Final Show Cause Notice.
- AND WHEREAS, the SRC in its 412th meeting held on 05th 06th July, 2022 has 4. considered the matter and the following observations were made:

The original files of the Institution alongwith other related documents, NCTE Act. 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice on 11.03.2022. The (i) failed submit reply along with documents/information to the Final Show Cause Notice (FSCN). Committee also noted that the institution has not even filed Performance Appraisal Report (PAR).

Hence the recognition granted to Akshara College of Education, Plot No. 13, Pamur Village & Post, Pamur Taluk, Prakasam District-523108, Andhra Pradesh for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counselling / making admissions from the next academic session i.e. 2023-2024.

- 5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Akshara College of Education, Plot No. 13, Pamur Village & Post, Pamur Taluk, Prakasam District-523108, Andhra Pradesh for conducting B.Ed. Programme of two years duration with an annual intake of 50 students (one basic unit) with effect from the end of next academic session i.e., 2023-2024. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate for counseling from the academic session i.e., 2023-2024 and the institution is also not permitted to take any fresh admission of students from the academic session 2023-2024.
- **6.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
