**CONTINUATION ORDER**

**WHEREAS**, the recognition was granted to the institution namely, **Miranda College of Education, C.A. 52, Hal 3<sup>rd</sup> Stage, Indiranagar, Bangalore, Karnataka-560075** run by **Miranda Education Society, Bangalore, Karnataka** vide SRC order No. F.SRO/NCTE/B.Ed./2004-2005/8723 on 29.11.2004 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 21.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.**

3. **AND WHEREAS**, the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup> – 15<sup>th</sup> September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC Show Cause was issued to the institution on 23.02.2021. The institution has submitted reply on 10.03.2021.

4. **AND WHEREAS**, the SRC in its 403<sup>rd</sup> meeting held on 18<sup>th</sup> – 19<sup>th</sup> October 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 03.11.2021. The institution has submitted reply on 15.11.2021.

5. **AND WHEREAS**, the SRC in its 405<sup>th</sup> Meeting held on 13<sup>th</sup> & 14<sup>th</sup> December, 2021 considered the matter and decided as follows: -

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -*

*The Committee on the perusal of the reply submitted by the institution, decided that the **continuation order** be issued to the Institution **Miranda College of Education, C.A. 52, Hal 3<sup>rd</sup> Stage, Indiranagar, Bangalore, Karnataka-560075** for **B.Ed. programme for 2 basic units of 50 students each.**"*

6. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Miranda College of Education, C.A. 52, Hal 3<sup>rd</sup> Stage, Indiranagar, Bangalore, Karnataka-560075** run by **Miranda Education Society, C.A. 52, Hal 3<sup>rd</sup> Stage, Indiranagar, Bangalore, Karnataka-560075** for Continuation of recognition for **B.Ed. programme** for two years duration with an

12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.
