CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely, **Konda Saraswathamma Hanumanthalah College of Education, S.K.P. Layout, Opp. Karnataka Sangh, Timmapur Pet, Raichur, Karnataka** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2004-2005/8758 dt. 29.11.2004 conducting Secondary B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2004-2005.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 02.03.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 18.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 388th meeting held on 14th – 15th September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 13.04.2021. The institution has submitted reply on 21.06.2021 & 30.06.2021.

4. **AND WHEREAS**, the SRC in its 402nd Meeting held on 13th & 14th September, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 08.10.2021. The institution has submitted reply on 03.11.2021 & 09.12.2021 request for 2 units to one unit.

5. **AND WHEREAS**, the SRC in its 405th Meeting held on 13th & 14th December, 2021 considered the request for 2 units to one unit matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the **continuation order** be issued to the Institution **Konda Saraswathamma Hanumathalah College of Education, Survey No. 873, Ward No. 16 S.K.P. Layout, Opp. Karnataka Sangh, Timmapur Pet, Raichur-584103, Karnataka** for B.Ed. programme for 1 basic unit of 50 students".

- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

11. The institution shall make available the list of students admitted on its official website.

12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
