CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely, **Alva's College of Education, Moodbidri, Mangalore Taluk, Dakshina Kannada District, Karnataka-574227** run by **Alva's Education Foundation, Moodbidri, Dakshina Kannada District, Karnataka** vide SRC order No. F.SRO/NCTE/B.Ed./2005-2006/4811 on 21.12.2005 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2005-2006.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 21.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.**

3. **AND WHEREAS**, the SRC in its 388th meeting held on 14th – 15th September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, a Show Cause Notice was issued to the institution on 13.04.2021. The institution has submitted reply on 14.06.2021.

4. **AND WHEREAS**, the SRC in its 400th Meeting held on 13th & 14th July 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 29.07.2021. The institution has submitted reply received on 08.12.2021.

5. **AND WHEREAS**, the SRC in its 405th Meeting held on 13th & 14th December, 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

*The Committee on the perusal of the reply submitted by the institution, decided that the **continuation order** be issued to the Institution **Alva's College of Education, Survey No. 341, Ward No. 5, Moodbidri, Mangalore Taluk, Dakshina Kannada District-574227, Karnataka** for **B.Ed. programme for 2 basic units of 50 students each.**"*

6. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Alva's College of Education, Survey No. 341, Ward No. 5, Moodbidri, Mangalore Taluk, Dakshina Kannada District-574227, Karnataka** run by **Alva's Education Foundation, Survey No. 341, Ward No. 5, Moodbidri, Mangalore Taluk, Dakshina Kannada District-574227, Karnataka** for

10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
11. The institution shall make available the list of students admitted on its official website.
12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
