CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely, **Bharathiyar College of Education, Ammampalayam Post, Attur Taluk, Salem District-636141, TamilNadu** vide SRC (NCTE) order no. F.TN/SEC/SRO/NCTE/2005-2006/1535 dt. 13.07.2005 conducting B.Ed. Course of one year duration with an annual intake of 100 students from the academic session 2005-2006.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 25.03.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 30.04.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 388th meeting held on 14th – 15th September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, a Show Cause Notice was issued to the institution on 10.09.2021. The institution has submitted reply on 30.11.2021.

4. **AND WHEREAS**, the SRC in its 405th Meeting held on 13th & 14th December, 2021 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the **continuation order** be issued to the Institution **Bharathiyar College of Education, Survey No. 49/3, 49/4, Ammampalayam Post, Attur Taluk, Salem District-636112, TamilNadu** for B.Ed. programme for **2 basic units of 50 students each**".

5. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Bharathiyar College of Education, Survey No. 49/3, 49/4, Ammampalayam Post, Attur Taluk, Salem District-636112, TamilNadu** run by **Sri Sakthi Educational Trust, 43/3, Salem to Cuddalore Main Road, Deviyakurichi PO, Attur TK, Salem DT, Tamilnadu-636112** for Continuation of recognition for B.Ed. programme for two-year duration with annual intake of **2 basic units of 50 students each** subject to fulfillment of the following conditions:



10. The institution shall make available the list of students admitted on its official website.

11. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
