WHEREAS, the recognition was granted to the institution namely, St. Joseph College of Education, Appicode, Tholayavattam P.O, Kanyakumari District, Tamilnadu-629157 for B.Ed, & B.Ed-Al programme as per following details:-

- (i) The SRC vide SRC (NCTE) order no. F.TN/SEC/SRO/NCTE/2005-2006/4047 dt. 17.11.2005 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.
- (ii) The SRC vide SRC (NCTE) order no F.SRO/NCTE/B.Ed.-Al/2006-2007/15437 dated 30.11.2007 for conducting Secondary B.Ed.-A.I. course of one-year duration with an annual intake of 200 (two hundred) students which includes the existing intake of 100 (Hundred) students and an additional intake of 100 (Hundred) students.
- 3. AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 17.01.2015.2015, A revised provisional recognition order was issued to the institution on 30.04.2015 for conducting B.Ed. programme of two years' duration with an annual intake of 100 from the academic session 2015-16 and in respect of B.Ed.-Al programme affidavit submitted by the institution on dt. 17.06.2015 and a revised provisional revised recognition order was issued to the institution on 01.07.2015 for conducting B.Ed.-Al programme of two years' duration with an annual intake of 100 students (two basic units) from the academic session 2015-2016.
- **4. AND WHEREAS,** the inspection was conducted on 02.11.2016 and the VT report received on 15.11.2016. The SRC in its 374<sup>th</sup> meeting held on 09<sup>th</sup> 10<sup>th</sup> April, 2019 considered the matter and decided to issue Show Cause Notice. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 15.04.2019. The institution has submitted reply on 23.05.2019.
- 6. **AND WHEREAS**, the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup> 15<sup>th</sup> September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 02.08.2021. The institution has submitted reply on 06.08.2021.
- 7. AND WHEREAS, the SRC in its 405<sup>th</sup> Meeting held on 13<sup>th</sup> & 14<sup>th</sup> December, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee on perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution St. Joseph College of Education, Survey No. 572/1, 572/2, 572/4, 615/1, 615/2, 584/1, Appicode, Tholayattam P.O. Kanyakumari District-629157, Tamilnadu for B.Ed. programme for 4 basic units of 50 students each."

- 8. NOW THEREFORE, this order is issued permitting the institution i.e., St. Joseph College of Education, Survey No. 572/1, 572/2, 572/4, 615/1, 615/2, 584/1, Appicode, Tholayattam P.O. Kanyakumari District-629157, Tamilnadu run by Muthaian Muthammal Educational Trust, Survey No. 572/1, 572/2, 572/4, 615/1, 615/2, 584/1, Appicode, Tholayattam P.O. Kanyakumari District-629157, Tamilnadu for Continuation of recognition for B.Ed. & B.Ed.-A.I. programme for two years duration with annual intake of 4 basic units of 50 students each subject to fulfilment of the following conditions:
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **9.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 10. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:

- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **12**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.
