CONTINUATION ORDER

**WHEREAS**, the recognition was granted to the institution namely, **Arunachala College of Education, Ayyampalayam Village & Post, Tiruvannamalai District-606603, Tamilnadu** vide SRC (NCTE) order no. F.SRO/NCTE/M.Ed./2006-2007/16511 dt. 31.08.2007 conducting M.Ed. Course of One year duration with an annual intake of 25 students.

2. **AND WHEREAS**, the enhancement of intake of 10 seats from existing 25 to 35 is permitted to **Arunachala College of Education, Ayyampalayam Village & Post, Tiruvannamalai District-606603, Tamilnadu** vide order No. F.SRO/NCTE/2010-2011/20585 dt. 23.08.2010 from the session 2010-2011.

3. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 31.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 25.05.2015 for conducting M.Ed. Programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-16.

4. **AND WHEREAS**, the SRC in its 369<sup>th</sup> Meeting held on 28<sup>th</sup> January 2019 considered the matter and decided to issue another SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the regional Committee. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 25.04.2019. The institution did not submit reply to the Show Cause Notice.

5. **AND WHEREAS**, the matter was further considered by the Sub-Committee constituted by the SRC as per its decision taken in 380<sup>th</sup> Meeting. The Sub-Committee of the SRC decided to issue Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 20.11.2019. The institution has submitted reply on 12.12.2019.

6. **AND WHEREAS**, the SRC in its 384<sup>th</sup> Meeting held on 12<sup>th</sup> & 13<sup>th</sup> February, 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 25.02.2020. The institution has submitted reply on 21.07.2020.

7. **AND WHEREAS**, the SRC in its 405<sup>th</sup> Meeting held on 13<sup>th</sup> & 14<sup>th</sup> December, 2021 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by



the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution **Arunachala College of Education, Survey No. 88/1A, 1B,1C,1D,1E,2A,4A,4B, 5 & 89/4B2B14, 4B2B17, Ayyampalayam Village & Post, Tiruvannamalai District-606603, Tamilnadu for M.Ed. programme for 1 basic unit of 50 students**".

**8. NOW THEREFORE,** this order is issued permitting the institution i.e., **Arunachala College of Education, Survey No. 88/1A, 1B,1C,1D,1E,2A,4A,4B, 5 & 89/4B2B14, 4B2B17, Ayyampalayam Village & Post, Tiruvannamalai District-606603, Tamilnadu run by Sai Jyothi Educational Trust, Tiruvannamalai, Tamilnadu-606601** for Continuation of recognition for M.Ed. programme for two-year duration with annual intake of **1 unit of 50 students** subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

**9.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

**10.** The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

**11.** The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:

- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

13. The institution shall make available the list of students admitted on its official website.

14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
