WHEREAS, the recognition was granted to the institution namely, Vivekananda College of Education, Sl.No.494/3, Siravayal Group, Thirupathur-Kariakudi Main Road, Kummangudi Village, Adhikaram Post, Sivangangal District, Tamilandu-630207 run by Vivekananda Educational Trust, Pudukkottai District, Tamilandu vide SRC order No. F.SRO/NCTE/B.Ed./2006-2007/17004 on 16.01.2008 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 25.10.2021. The institution has submitted reply on 08.12.2021.
- **4. AND WHEREAS,** the SRC in its 405<sup>th</sup> Meeting held on 13<sup>th</sup> & 14<sup>th</sup> December, 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Vivekananda College of Education, Survey No.494/3, Siravayal Group, Thirupathur-Kariakudi Main Road, Kummangudi Village, Adhikaram Post, Sivangangal District, Tamilandu-630207 for B.Ed. programme for 2 basic units of 50 students each."
