WHEREAS, the recognition were granted to the following 57 institutions for conducting D.El.Ed. Course of two years duration by the SRC, NCTE.

2. AND WHEREAS, a letter no. RC. No. ESE02-22025/43/2020-(SCERT) TRG-DSE dated 25.03.2021 was received from Sri V. Chinaveerabhadrudu, I.A.S. Director, School Education, Andhra Pradesh, Amaravati inter -alia recommending the derecognition of various private D.El.Ed. College on the ground of violation of admission rules stipulated by the State Government. The operative part of the letter is reproduced below:-

"I wish to submit that the Government of Andhra Pradesh vide G.O. Ms. No. 30 School Education (Prog. 110 Detp., dt. 08.07.2015 has issued the rules relating to admissions of students into Elementary Teacher Training Institutes/District Institutes of Education and Training through Common Entrance Test Rules 2015. Further with regard to admissions of students into Elementary Teacher Training Institutes as stipulated under Rule 6 (i) (A) (xiii) is as follows: -

"Any admissions undertaken by private Un-aided non-minority or minority colleges to fill the vacant seats after completion of the Special Counselling on their own, deviating from Government order shall be treated as irregular. All such admission will be cancelled at any time by Government and serious note taken against the institutions for the violation. De-Recognition of such Private D.El.Ed. College shall be recommended to the NCTE."

Reiterating the above rules, the Government of Andhra Pradesh vide Govt. Memo. No. ESE01-SEDN0CSE/411/2019-Prog. II dt. 11.06.2019 have directed the Commissioner of School Education to take serious view against the Pvt. D.EI.Ed. College for violation of rules relating to admission of students into D.EI.Ed. course and instructed to recommend against such Pvt. D.EI.Ed. College to the NCTE for de-recognition.

In this connection, I submit that even though there are specific rules in regarding to filling up vacant seats after completion of DEECET counselling, the managements of (417) Pvt. D.El.Ed. Colleges have made admissions into D.El.Ed. course during 2018-19 on their own in violation of Government orders and these Pvt. D.El.Ed. college are liable for de-recognition as per the list enclosed.

Since these managements of Pvt. D.El.Ed. college have made admissions into D.El.Ed. course during 2018-19 on their own in violation of Government order. I request the NCTE to issue necessary de-recognition orders in respect of the above (417) Pvt. D.El.Ed. College in Andhra Pradesh. Incl: (417 College list enclosed)."

3. AND WHEREAS, the matter was considered by the Southern Regional Committee of NCTE in its 401st Meeting held on 11th & 12th August, 2021 wherein the Committee held the following:-

"The Committee perused the letter dt. 25.03.2021 issued by the School Education Department, Govt. of Andhra Pradesh establishing the violation made by 417 TEIs (list enclosed as Annexure 'A' to this minutes). These TEIs have made admissions into D.EI.Ed. course during 2018-19 on their own without adhering the rules and regulations. Therefore, the Govt. of Andhra Pradesh in this instant letter recommended SRC, NCTE to de-recognize these TEIs henceforth.

The Committee discussed the issue in detail and decided to direct the Regional Director that instead of sending individual Show Cause Notices to all the 417 TEIs to save time particularly in the context of COVID 19pandemic, all the TEIs to be derecognize be uploaded on SRC, NCTE's website alongwith the 13 point schedule asking the managements to furnish the information to the points included in the 13 point schedule within 21 days either online or by post treating it as a Show Cause Notice. Accordingly, process the withdrawal of recognition as desired by the Govt. of Andhra Pradesh."

- 4. AND WHEREAS, consequent upon the above decision of SRC, Show Cause Notices were issued on 18.08.2021 to 417 institutions.
- 5. AND WHEREAS, the matter of institutions who have not submitted the reply within the stipulated period of time was considered by the SRC in its 402nd meeting held on 13th& 14th September, 2021 wherein the Committee decided the following:-

"The Committee discussed the matter pertaining to the withdrawal of recognition to the TEIs offering D.EI.Ed. programme in Andhra Pradesh as desired by the School Education Department, Govt. of Andhra Pradesh. It is resolved to withdraw the recognition of all such TEIs who have failed to respond to the notice (published on the NCTE website) and also sent to the TEIs through e-mail. The RD, SRC is advised to serve withdrawal orders accordingly."

- **6. AND WHEREAS,** as per decision of SRC, a common withdrawal order dt. 05.10.2021 was issued to 378 institutions.
- 7. AND WHEREAS, 68 institutions (list attached as Annexure-A) have approached the Hon'ble High Court of Andhra Pradesh at Amravati. The Hon'ble High Court has directed as under:-
 - 6. "In that view of the matter, the order dated 05.10.2021 passed by respondent no. 3 is hereby set aside. Respondent no. 3 may initiate proceedings by issuing fresh Show Cause Notice to all the petitioners-colleges through email as well as registered post with acknowledgement due within a period of three weeks from the date of receipt of a copy of this order if he is so advised. On receipt of such Show Cause Notice, the petitioners-colleges are directed to offer their explanations within a period of four weeks thereafter and on such explanations, if any, being offered by the petitioners-colleges, respondent no. 3 is directed to pass appropriate orders in accordance with law within a period of four weeks thereafter and communicate the same to the petitioner.
 - 7. The writ petitions are allowed accordingly. Pending miscellaneous applications, if any, shall stand closed in consequence. No costs."

8. AND WHEREAS, the SRC in its 418th Meeting held on 16th December, 2022 considered the matter and the Committee decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

In compliance of order dated 15.11.2022 passed by Hon'ble High Court of Andhra Pradesh at Amaravati, the Committee considered the matter and decided to issue Show Cause Notice to the institution.

9. AND WHEREAS, as per decision of SRC, a common Show Cause Notice dated 16.01.2023 was issued to 68 institutions. Out of 68 institutions only one institution has submitted reply of Show Cause Notice. The matter of 67 institutions who have failed to submit response to Show Cause Notice were placed before the SRC in its 421st meeting held on 10th February 2023 and the Committee has decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

(i) The institution failed to submit reply to the Show Cause Notice dated 16.01.2023.

Therefore, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned in SCN to the institution. The institution is required to submit the documents within 7 days from the date of issue of Final Show Cause Notice."

10. AND WHEREAS, as per decision of SRC, a common Final Show Cause Notice dated 20.02.2023 was issued to 57 institutions. Out of 68 institutions only eleven institution has submitted reply of Show Cause Notice & Final Show Cause Notice. The matter of 57 institutions who have failed to submit response to Final Show Cause Notice were placed before the SRC in its 422nd meeting held on 02nd & 03rd March 2023 and the Committee has decided to withdraw the recognition.

NOW, THEREFORE, in exercise of the power vested u/s 17 of NCTE Act, 1993, the Southern Regional Committee here by withdraw the recognition granted to 57 institutions which have not submitted reply Final Show Cause Notice out of 68 colleges for conducting D.El.Ed. & D.El.Ed-Al programme of two years durations. No fresh admissions are permitted now onwards. However, if any student is pursuing D.El.Ed., D.El.Ed-Al programme is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
