WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely, M.E.S. Teachers College, "Vidya Vihara", #25/1, 17th Main, 2nd Block, Rajajinagar, Bangalore, Karnataka-10 vide order no. F.KAR/B.Ed./02/SRO/NCTE/2000-2001/942 dt. 10.07.2000 for B.Ed. course of one year duration from the academic session 2000-2001 with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 28.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 16.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, a Corrigendum vide order no. F.SRO/NCTE/APS03394/B.Ed./KA/2015-16/79170 dt. 01.01.2016 was issued to the institution for conducting B.Ed. programme of two years duration with an annual intake of 50 students of one basic unit from the academic session 2015-16.
- 4. AND WHEREAS, the SRC in 369th Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, as per decision a Show Cause was issued to the institution on 24.04.2019. The institution did not submit any reply to Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 388th Meeting held on 14th& 15th September, 2020 considered the matter placed before the committee and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 13.10.2020. The institution has submitted its reply on 18.12.2020.
- 6. **AND WHEREAS,** the SRC in its 393rd Meeting held on 05th& 06th January 2021 considered the matter and decided to issue Last Reminder (Letter) to the institution. Accordingly, as per decision of SRC Last Reminder (Letter) was issued to the institution on 19.01.2021. The institution has submitted its reply on 07.01.2021.
- 7. **AND WHEREAS,** the SRC in its 414th Meeting held on 26th & 27th September, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made were made: -

The institution was issued a Last Reminder Letter (Letter). The institution has submitted its on 07.01.2021. The Committee perused the reply submitted by the institution and found the following deficiencies.

- 1. The institution has not submitted latest faculty list approved by the Affiliating Body. The earlier faculty list submitted by the institution is not sufficient in terms of NCTE Regulation 2014.
- 2. Building Plan is not approved by the Competent Authority.
- 3. The institution has submitted lease deed dated 25.04.2012 executed between Bangalore development authority and managing society of the institution. Whereas the institution is functioning since 1997. The institution did not apply for shifting of the premises.
- 4. NEC has not been submitted.

Hence the recognition granted to M.E.S Teachers College, "Vidya Vihara", # 25/1, 17th Main, 2nd Block, Rajajinagar, Bangalore, Karnataka-10 for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the academic year 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn."

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraw the recognition granted to M.E.S Teachers College, "Vidya Vihara", # 25/1, 17th Main, 2nd Block, Rajajinagar, Bangalore, Karnataka-560010 run by Mumbai Karnataka Shikshana Trust's, "Vidya Vihara", # 25/1, 17th Main, 2nd Block, Rajajinagar, Bangalore, Karnataka-560010 for conducting B.Ed. programme of two years duration with an annual intake of 50 students (1 basic unit) with effect from the next academic session i.e., 2023-2024 onwards.
- 9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
