ORDER

In exercise of the powers vested under Section 14(3)(a) of the National Council For Teacher Education(NCTE) Act, 1993, the Southern Regional Committee grants recognition to A.S.M.M. Teacher Training Institute, Alathur PO – 678541, Palghat District, Kerala for Elementary Course of two years duration from the academic session 2000-2001 with an annual intake of 22, subject to fulfilling the following conditions :

- 1. The institution shall appoint within a period of one year 4 additional teaching staff possessing the academic qualifications as laid down in the NCTE norms in the salary structure prescribed by the UGC/Central Government/State Government, as the case may be.
- 2. All such teachers already appointed who do not have qualifications as per NCTE norms shall acquire the qualifications as per the norms within a period of two years of this order.
- 3. Librarian and Library Assistant should be appointed.
- 4. Physical Education teacher and instructors for Work Experience, Art & Music and Education
- Technology should be appointed.
- 5. Science lab, Psychology lab, Education Technology lab and Work Experience lab should be equipped as per NCTE norms.
- 6. 3 educational journals should be subscribed to as per NCTE norms.
- 7. Accommodation for Education Technology lab, Workshop, Games & Sports and Art & Music
- 8. The admission to the approved course shall be given only to those candidates who are eligible room should be provided.
- as per the regulations governing the course and in the manner laid down by the affiliating University/ State Government as the case may be.
- 9. Tuition fee and other fees will be charged from the students as per the norms of the affiliating University / State Government as the case may be till such time NCTE regulations in respect of fee structure come into force.
- 10. Curriculum transaction, including practical work / activities, should be organised as per the norms and standards for the course and the requirements of the affiliating University / examining body as the case may be.
- 11. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
- 12. The institution, if unaided, shall maintain endowment and reserve fund as per NCTE norms.
- 13. The institution shall continue to fulfil the norms laid down under the regulations of the
- NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The performance appraisal report should inter alia give the extent of compliance of the conditions indicated above.

If A.S.M.M. Teacher Training Institute, Alathur PO - 678541, Palghat District, Kerala contravenes the provisions of the NCTE Act or the rules, regulation and orders made or issued thereunder or fails to fulfil the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.
