Preamble:

AVS Teacher Training Institute, Gantekanive, N.H.206, B.H.Road, M.C.Halli Post, Tarikere Taluk, Chikamagalur District, Karnataka has submitted application for D.Ed course on 02.01.2006. The institution was refused recognition vide order dated 20.04.2007. The institution preferred appeal under section 18 of NCTE Act before NCTE, New Delhi and the appellate authority has also confirmed the orders of SRC.

The institution approached the Hon'ble Court in W.P. 7 of 2008 and W.P. 8 of 2008 considering the writ petitions, the Hon'ble High Court of Karnataka in its Judgement dated 25.08.2008 has passed common judgement in both the petitions stating that :

"In the instant case, it is seen from the Additional report filed, the structure existing is not said to be sufficient for the running the D.Ed course and in the circumstance it is for the petitioner to comply with the requirement of the space for running the course and also the other observations made as per the report and to comply with the same for seeking permission from the NCTE. The petitioner after such compliance would approach once again the respondent authority. The respondent authority shall consider the request of the petitioner in accordance with law at the earliest if it is found fit in accordance with law for the next academic year."

The institution in its letter dated 20.11.2008 has requested to re-consider their application based on the directions of the Hon'ble court. As the directions of the Hon'ble court was not clear, the opinion from the Counsel of NCTE Sri.Ashok Haranahalli was sought.

As per court directions and legal opinion of the advocate, a letter was sent to the institution on 30.04.2009 seeking to submit duly filled in questionnaire along with required documents on or before 07th May 2009. The institution has submitted its written representation. The same was considered by SRC in its 176th meeting held on 27-28 May 2009 and decided to cause re-inspection.

Accordingly, re-inspection of the institution was carried out on 08.07.2009. The re-inspection report was considered by SRC in its 176th meeting held on 13-14 July 2009 and decided to refuse recognition. Accordingly, order of refusal was issued to the institution vide order dated 11.08.2009.

The institution preferred appeal and the Appellate Authority in its order dated 07.06.2010 has stated as follows:

".....the appeal was accepted and set aside the order of the SRC's order dt.11.08.2009 and remand the case to the SRC for issuance of letter of intent prior to grant of recognition under clause 7(9) of the NCTE Regulations. The final decision of the SRC, if it decides to grant recognition would, however, be made operative from the date of withdrawal of the ban on further recognition of D.Ed course in the State of Karnataka imposed by the NCTE and notified vide Public Notice dated 28.07.2009."

The Appellate Authority order was placed before SRC in its 193rd meeting held on 21-22 June 2010 and SRC decided as under:

"The Committee noted the appellate authority order dated 7.6.2010 remanding the case to the SRC and decided to issue letter of intent prior to grant of recognition under clause 7(9) of the NCTE regulations. The Committee also noted and decided that the final decision of grant recognition, if any, would, however, be made operative from the date of withdrawal of the ban of D.Ed. course in the state of Karnataka imposed by the NCTE and notified vide Public Notice dated 28.7.2009".

Accordingly, a letter was issued to the institution on 10.08.2010.

The institution approached the Hon'ble Court in W.P.25699 of 2010 and passed judgement on 18.01.2011 which reads as follows:

The writ petition is allowed in part. The order dt.07.06.2010 Annex.E, of the 1st respondent (NCTE, New Delhi) in so far it relates to the observation, "the final decision of SRC, if it decides to grant recognition would, however, be made operative from the date of withdrawal of the ban on further recognition of D.Ed course in the State of Karnataka imposed by the NCTE and notified vide Public Notice dt.28.07.2009", is quashed. The 2nd respondent, SRC, is directed to comply with the order Annex.E forthwith.

The SRC in its 201st meeting held on 22-23 February 2011 considered the directions dated 18.01.2011 of the Hon'ble Court of Karnataka in W.P.25699 of 2010 and decided to issue Letter of Intent before grant of formal recognition under regulations 7(11). Accordingly, Letter of Intent was issued to the institution on 09.03.2011. The institution has submitted its reply on 25.04.2011. SRC considered the reply to LOI and decided to issue Notice. Accordingly, notice was issued to the institution on 30.05.2011. The institution submitted reply on 09.06.2011.

The SRC in its 207th meeting held on 23rd June 2011 considered the reply and decided to issue formal recognition.

Hence the order.

ORDER


WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 **A.V.S. Education Trust, Gantekanive, N.H,206, B.H.Road, M.C. Halli (Post) – 577221, Tarikere Taluk, Chickmagalur District, Karnataka** has submitted an application to the Southern Regional Committee of NCTE for grant of recognition **AVS Teacher Training Institute, Gantekanive, N.H. 206, B.H. Road, M.C.Halli Post, Tarikere Taluk, Chickmagalur District, Karnataka** for conducting D.Ed course with an intake of 50 students on 02.01.2006.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the **Elementary** Teacher Education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to **AVS Teacher Training Institute, Gantekanive, N.H. 206, B.H. Road, M.C.Halli Post, Tarikere Taluk, Chickmagalur District, Karnataka** for conducting **D.Ed** Course of Two years duration with an annual intake of **50** students from the academic session **2011-12** under clause 7(11) of NCTE(Recognition Norms & Procedure) Regulations, 2009 and NCTE Amendment Regulation 2010 dated 26.07.2010 subject of fulfillment of the following conditions:
- I. The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or Mortgaging of FDRs shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.
 - IV. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.
5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
- (i) Copy of the Application Form
 - (ii) Land and Building Particulars
 - (iii) Staff Profile
 - (iv) Recognition letter
 - (v) Information for having fulfilled the norms & standard and other required conditions.
7. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
