ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993 Aathavan Teacher Training Institute, No. 16-7-7, Manapatti, Singampunarai-630502, Sivagangai District, Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for D.T.Ed Course on 29.12.2005.

AND WHEREAS, the Southern Regional Committee, after considering the report of the visiting team as well as other relevant materials granted recognition to the institution for D.T.Ed course on 24.10.2006 with an annual intake of 50 students with stipulation that the institution shall shift to its own premises/building within three years from the date of recognition.

AND WHEREAS, the institution vide its letter dated 29.10.2008 submitted Rs.40000/- towards shifting fee. A letter was issued on 12.06.2009 to the institution calling for documents to examine the proposal for shifting of premises. The institution submitted its reply on 06.07.2009. Meanwhile the Directorate of Teacher Education, Research and Training Chennai-600006 forwarded a copy of inspection report of the institutions conducted by Principal, District Institute of Education and Training. SRC considered the report in its 202<sup>nd</sup> meeting held on 14-15 March 2011 and decided to issue show cause notices. Accordingly, notice was issued to the institution on 12.04.2011.

AND WHEREAS, the institution while submitting its reply on 25.04.2011, requested for the copy of complaint letter of DTERT, Tamilnadu. The committee decided to give the copy of the complaint letter received from Director of Teacher Education, Research and Training Chennai, to the institution. Further, it was decided that in all such cases of specific complaints, the Regional Director be authorised to send the copy of the complaint to the concerned institution and also call for remarks of the institution, and on receipt of the same, the Regional Director may put up the whole thing as an agenda before SRC.

AND WHEREAS, accordingly, as per the decision of SRC, a copy of complaint which was received from DTERT, Chennai, was forwarded to the institution on 27.06.2011. But the institution has not submitted its reply so far. Instead the institution filed Court case in WP No. 10486 of 2011 and MP NO. 1 of 2011 filed by Aathavan Teacher Training institute, Sivagangai District, Tamilnadu against SRC's show cause notice No. SRO/NCTE/2010/28109 Dt. 12.04.2011 and as per interim order dt. 05.04.2011, the Hon'ble court has granted stay on the Show Cause Notice dt. 12.04.2011.

AND WHEREAS, the Court has ordered as follows ".... the petitioner restricted his prayer to the effect that the 1<sup>st</sup> respondent shall proceed with the enquiry and pass orders on the basis of the inspection report dated 31.05.2011 submitted by him. In view of such limited prayer, this court without going into the merits of the other aspects., Is constrained to direct the 1<sup>st</sup> respondent herein to proceed with the enquiry and to pass orders in accordance with law by considering all the factors including the inspection report dated 31.05.2011 within a period of four weeks from the date of receipt of a copy of this order".

AND WHEREAS, the Show Cause Notice dated 12.04.2011 was not replied to SRC. The institute only replied vide letter dated 25.04.2011 stating that " we wish to inform you that you have issued a Show cause notice to us based on the inspection report conducted on our institution by the DTERT. We wish to inform you that the DTERT has not conducted any inspection of late and we were not furnished with the copy of the report of the inspection team of the DTERT. I therefore request that before proceeding further, a copy, of the report of the DTERT may be furnished to us to enable us to give a reply to your Show Cause Notice.

AND WHEREAS, the matter was placed before SRC in its 209<sup>th</sup> meeting held on 31<sup>st</sup> July 2011 and SRC decided to cause inspection. The inspection was already carried out on 31.05.2011.

AND WHEREAS, the SRC in its 211<sup>th</sup> meeting held on 21<sup>st</sup>-23<sup>rd</sup> September, 2011 considered the VT Report, VCD and all the relevant documentary evidences and decided to serve Show cause Notice under Section 17 of NCTE Act. Accordingly, a Show cause notice was issued to the institution on 17.11.2011. The institution had submitted its written representation on 13.12.2011.

AND WHEREAS, the SRC in its 216<sup>th</sup> meeting held on 11<sup>th</sup>-12<sup>th</sup> January 2012 considered the reply of the institution dt. 13.12.2012, VT Report, VCD and all the relevant documentary evidences and decided to serve Final Show cause Notice under Section 17 of NCTE Act for the following:

- In the Affidavit submitted by the institution, the survey numbers are not mentioned.
- Latest original Non-encumbrance certificate is not submitted.
- Original FDRs for Rs. 5 & 3 lacs towards endowment and reserve fund from a Nationalised Bank in joint account is not submitted.
- Salary to the staff are paid by cash not through Cheque.

AND WHEREAS, accordingly, a final show cause notice was issued to the institution on 27.02.2012. The institution had submitted its written representation on 21.03.2012.

AND WHEREAS, the SRC in its 221<sup>st</sup> meeting held on 19<sup>th</sup>-20<sup>th</sup> April, 2012 considered the written reply of the institution other related documents along with the original file of the institution for shifting to new/permanent premises and decided to permit shifting to new premises is permitted.

NOW THEREFORE, permission is hereby accorded by SRC to **Aathavan Teacher Training Institute, No. 16-7-7, Manapatti, Singampunarai-630502, Sivagangai District, Tamilnadu** to shift its premises to the new location / building at **Aathavan Teacher Training Institute, No. 43, M. Kovilpatti, Singampunari, Sivaganga District, Tamilnadu** for all courses.
