ORDER**

WHEREAS, the recognition was granted for B.Ed course on 03.03.2003 with an annual intake of 100 students. The institution was also granted recognition for D.Ed course on 26.08.2005 with annual intake of 50 students.

AND WHEREAS, the institution has submitted shifting proposal on 01.10.2007 along with DD of Rs.40,000/- which is taken into account.

AND WHEREAS, accordingly, a letter was sent to institution on 25.05.2009, to submit relevant documents.

AND WHEREAS, inspection of the institution for shifting of premises was fixed on 7th -12th February 2011. Inspection of the institution was conducted for both B.Ed & D.Ed. courses on 07.02.2011.

AND WHEREAS, the SRC in its 211th meeting held on 21-23 September 2011 considered VT report, VCD and all the relevant documentary evidences and it was decided to serve Show cause Notice under Section 17 of NCTE Act.

AND WHEREAS, show cause notice was issued on 14.11.2011. Reply received from the institution on 15.12.2011.

AND WHEREAS, the institution has submitted its written representation on 27.01.2015 along with willingness affidavit as per regulation 2014.

AND WHEREAS, revised recognition order for B.Ed course was issued to the institution on 13.05.2015 with a condition that the institution has not shifted to its own premises as stipulated in its formal recognition order dated 03.03.2003.

AND WHEREAS, the institution was submitted its written representation on 02.09.2015, along with a copy of written representation on 26.06.2015, 14.09.2015 and 23.09.2015 regarding shifting of building in its own premises.

AND WHEREAS, the SRC in its 292nd meeting held on 29th & 30th September 2015, considered the written representations from the institution and decided to permit shifting for both B.Ed and D.El.Ed.

NOW THEREFORE, permission is hereby accorded to Adarsh College of Teacher Education, Mahabubnagar Revenue Division, Venkateshwara Colony, Mahabubnagar District – 509002, Andhra Pradesh to shift its premises to new location/building at Adarsh College of Teacher Education, Plot/Khasara No.136/A, Malleboinpally Village & Post, Jadcherla Taluk, Mahabubnagar District – 509301, Telangana for B.Ed and D.El.Ed.

Further, in view of the fact that NCTE Regulations (Recognition, Norms and Standards) 2014 are notified, the institution is required to conform to the new requirements as prescribed in NCTE Regulations (Regulation, Norms and Standards), 2014 and submit compliance before 31.10.2015.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
