ORDER

WHEREAS, Ameerudin Academy of General Technical and Professional Educational Society, Plot No. 120/U, Komuravelly Kaman Street, Sarlapalli Village, Thijmareddypalli Post and Town, Kondapak Taluka, Medak Distt- 502372, Andhra Pradesh had applied for grant of recognition to AK College of Teacher Education Muslim Minority Institution, Plot No.121/A, Sarlapalli Village, Thijmareddypalli Post and Town, Kondapak Taluka, Medak-502372, Andhra Pradesh for D.El.Ed Course of two year duration under Section 14(1) of the NCTE Act, 1993 to the Southern Regional Committee, NCTE online 27.09.2010

AND WHEREAS, the application was scrutinized and a copy of application was sent to State Government for recommendation on 09.11.2010/02.02.2011. A deficiency letter was issued to the institution on 10.12.2010.

AND WHEREAS, the inspection of the institution was conducted on 30.03.2011. The SRC in its 204th Meeting held on 27th-28th April 2011 considered the VT Report, VCD and all the relevant documentary evidences and it was decided to serve the Show Cause Notice.

AND WHEREAS, as per direction of SRC, Show Cause Notice was issued to the applicant institution on 02.06.2011. In response to this Show Cause Notice dt.02.06.2011 the institution submitted reply vide letter dt. 24.06.2011.

AND WHEREAS, Southern Regional Committee in its 208th meeting held on 13th & 14th of July 2011 decided to issue Letter of Intent to the institution prior to grant of recognition. LOI was issued on 20.07.2011. In response to LOI dated 20.07.2011 the institution has submitted reply vide letter dt. 11.08.2011.

AND WHEREAS, the SRC in its 210th Meeting held on 22nd-23rd considered the reply of the institution dt. 11.08.2011 and it was decided to serve Notice Under Section 17 of NCTE Act. As per decision of SRC Show Cause Notice was issued on 28.10.2011. In response to this Show Cause Notice dt. 28.10.2011 the institution has submitted reply vide letter dt. 24.10.2011 and 04.11.2011.

The matter was placed in 213th SRC meeting held on 6th-7th Nov 2011. The committee considered the reply to Notice and other documents submitted by the Institution and decided to issue Formal Recognition.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to **AK College of Teacher Education Muslim Minority Institution, Plot No.121/A, Sarlapalli Village, Thimmareddypalli Post and Town, Kondapak Taluka, Medak-502372, Andhra Pradesh** for conducting **D.El.Ed** Course of two years duration with intake of 50 Students from the academic session **2012-2013** under clause 7(11) of NCTE Regulations, 2009 subject, to fulfillment of the following conditions:

- i The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.
- ii The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
- iii The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
- iv The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- v The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- vi The institution / Management shall produce valid minority certificate from the notified authority of the respective State Government for the subsequent years 2012-13 onwards.

Further Southern Regional Committee in its 208th Meeting held on 13th and 14th July 2011 also resolved that the institutions which have fulfilled all the requirements as per norms and regulations excepting the minority certificate be directed to submit a notarized statement/undertaking

- 1) The Institution shall declare themselves as minority trust and minority institution proposed to be established and give an undertaking that the management shall produce valid minority certificate from the notified authority of the respective State Government on or before 31st March 2012, failing which, the institution shall be de-recognized automatically without any further notice and that such institutions shall make no further admission thereafter.
- 2) The said institution has submitted minority certificate only for 2011-12 and for 2012 -2013 as such requisite undertaking may be submitted immediately.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.



- 1) Copy of the Application Form
- 2) Land and Building Particulars
- 3) Staff Profile
- 4) Recognition letter
- 5) Information for having fulfilled the norms & standard and other required conditions.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
