### PREAMBLE:

Annai Sampoorani Ammal Charitable Trust, Namakkal District has submitted an application for seeking grant of recognition for D.T.Ed course on 15.12.1999 without the processing fee and NOC/Endorsement from the State Government of Tamilnadu and the application was returned back on 23.6.2000.

However, consequent to Hon'ble High Court of Madras in W.P. No. 19337 of 2005 directing "the SRC-NCTE to process the application of the petitioner dated 15.12.1999 with regard to its two year D.T.Ed programme for the academic years 2005-06 by conducting proper inspection of the petitioner's institution and considering only the report of the inspection team of the SRC, Bangalore", as per the directions of Hon'ble High Court of Madras in the Contempt Petition No. 1003 of 2005, an inspection of the institution was carried out on 8.9.2006 to verify the essential documents as per Appendix-1B of NCTE Regulation, human Resources, infrastructural and instructional facilities provided by the institution for elementary course.

The visiting team report was placed before SRC in its 117<sup>th</sup> meeting held on 13, 14<sup>th</sup> and 19<sup>th</sup> September, 2006.

And whereas upon consideration of the inspection team report submitted by the visiting team and other documents furnished by the institution along with the application, the Regional Committee, observed that the institution prima facie, does not fulfill the requirements, the norms and standards laid down by the NCTE in accordance with the provisions of the NCTE Act, 1993.

Accordingly a notice was issued to the institution on 10.10.2006. The written representation dated 18.10.2006 submitted by the institution was placed in the 120<sup>th</sup> SRC meeting held on 3-4<sup>th</sup> November, 2006 and the matter was deferred. Subsequently, the proposal was considered in 122<sup>nd</sup> SRC meeting held on 4-5<sup>th</sup> December, 2006.

SRC considered the written representation submitted by the institution and also examined the documents available in the original file related to the above institution and found that the infrastructural and instructional facilities are provided satisfactorily and decided to accord recognition for starting D.T.Ed course with an intake of 50 students.

Hence the order.

## ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Annai J.K.K. Sampoorani Ammal Charitable Trust, Namakkal District, Tamilnadu has submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Annai J.K.K. Sampoorani Ammal Teacher Training Institute, Ethirmedu, Valayakaranur Post, Komarapalayam – 638183, Namakkal District, Tamilnadu for Elementary(D.T.Ed) course of two years duration with an annual intake of 50(Fifty) students.

- 2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and Videography, the Committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc for running the programme and has appointed duly qualified teaching staff as per NCTE norms.
- Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Annai J.K.K. Sampoorani Ammal Teacher Training Institute, Ethirmedu, Valayakaranur Post, Komarapalayam-638183, Namakkal District, Tamilnadu for conducting Elementary(D.T.Ed) course of two years duration with an annual intake of 50(Fifty) students under clause 7(12) of Regulations dated 13.1.2006. This order of recognition shall be prospective and take effect from the date of issue of this order, subject to fulfillment of the following:
  - The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
  - The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
  - iii. The institution shall shift to its own premises/building within three years from the date of recognition(in case the course is started in rented premises).

- iv. The institution will ensure that Principal and Five faculty members duly approved by DTERT, Chennal are in position for an intake of 50 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/bodies, State Government etc, as applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain and update the Website as per provisions of NCTE Regulations.
- If the institution contravenes any of the above conditions or any of the
  provisions of the NCTE Act, Rules, Regulations and orders made or issued
  there under, the Regional Committee shall withdraw the recognition under the
  provisions of Section 17(1) of the NCTE Act.
