 - iii) The institution will ensure that Principal and Eight faculty members duly approved by DTERT, Chennai are in position for an intake of 100 students before commencement of the course and a report to this stiect shall be sent to the Southern Regional Committee immediately.

- 8. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition under the provisions of Section 17/1) of the NCTE Act.
