ORDER

WHEREAS, Annamacharya College of Education, Rajampet Revenue Division, New Boyanapalli,, Cuddapah Distrit-516126, Andhra Pradesh had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for B.Ed course of one year duration from the academic session 2002-03 and was granted recognition on 03.03.2003 with the condition to shift to its own prmises/ building within three years from the date of recognition. ( in case the course is started in rented premises).

AND WHEREAS, on 20.01.2015, the institution has submitted an affidavit for offering B.Ed course as per Regulations 2014. Accordingly, a revised order was issued to the institution on 12.05.2015.

AND WHEREAS, on 05.06.2015, annamacharya Educational Trust, Plot No. 1084/1, A.I.T.S.Campus ,New Boyanapalli Village and Post Office ,Rajampet Taluk and Town,Kadapa District - 516126, Andhra Pradesh has applied for grant of recognition to Annamacharya College of Education, Plot No. 1084/1, AITS Campus,New Boyanapalli Village and Post Office , Rajampet Taluk and Town, Kadapa District – 516126, Andhra Pradesh for offering M.Ed- AI course of 2 years duration for the academic session 2016-17 under Section 14/15 of the NCTE Act, 1993 to the Southern Regional Committee , NCTE.

AND WHEREAS, the SRC in its 294<sup>th</sup> meeting held during 14<sup>th</sup> – 16<sup>th</sup> November, 2015 has considered the matter, documents submitted by the institution along with hard copy of application and decided as under:

1. Copy of Bye –Laws of Society and FDRs not submitted.
- 2.'B' Certificate by NAAC is submitted. However, the institution should be accredited with 'B+' Certificate.
- 3.Shifting of premises is still pending.
4. Obtain inspection fee for shifting
5. Apprise the applicant of these deficiencies for necessary action.
6. Ask the VT to collect all relevant documents and check for removal of deficiencies.
7. Cause composite inspection

AND WHEREAS, as per the decision of SRC a composite inspection was conducted on 27.01.2016 and the Visiting team report is received by this office on 01.01.2016. The SRC in its 301<sup>st</sup> meeting held during 05<sup>th</sup> to 06<sup>th</sup> February, 2016 considered VT report and relevant documents decided as under:-

1. Shifting permission for existing B.Ed and M.Ed.
2. Issue LOI for M.Ed-AI (1 unit)
3. For M.Ed (basic unit) and M.Ed-AI combined staff list should be produced in accordance with the norms given in 2014 Regulations.
4. FDRs in Joint account should be furnished.
5. Only if these are given or before 3.3.16 can issue of Formal Recognition w.e.f. 2016-17 academic year be possible."
