WHEREAS, recognition was granted to the institution namely Bapuji College of Education, No. 16/7/30,31 Sheraff Bazar, Tenali, Guntur District-522403, Andhra Pradesh run by Kamala Educational Society, Guntur District, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/APSO7958/B.Ed/2007-2008/13131 dt. 18.10.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 29.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHREAS, on the basis of request, the SRC in its 342nd meeting decided for reduction of intake from 2 units to 1 unit. Accordingly, a order No. F.No.SRO/NCTE/APSO7958/B.Ed/AP/2017-18/94301 dated 09.08.2017 was issued reducing intake from 2 units to 1 unit.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 considered the matter and decided that Show Cause Notice be issued to all such institutions which have not submitted compliance of conditions stipulated in RPRO.

AND WHEREAS, as per the decision of SRC a show cause notice was issued to the institution on 18.02.2019. The institution vide letter dated 13.03.2019 submitted reply to the show cause notice.

AND WHEREAS, the SRC in its 377th meeting held on 03rd & 04th July, 2019 considered the matter and decided as under:

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

(i) The institution failed to submit requisite documents as per SCN dated 18.02.2019.

The Committee decided to withdraw the recognition granted to Bapuji College of Education, No 16/7/30, 31 Sheraff Bazar, Tenali Guntur District – 522403,

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Bapuji College of Education, No. 16/7/30,31 Sheraff Bazar, Tenali, Guntur District-522403, Andhra Pradesh run by Kamala Educational Society, Guntur District, Andhra Pradesh for conducting B.Ed programme of two years duration with an annual intake of 50 students (1 vide order No. finally allowed to the Institution unit) which were F.No.SRO/NCTE/APSO7958/B.Ed/AP/2017-18/94301 dated 09.08.2017on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order.
