ORDER

WHEREAS, the recognition was granted to the institution namely Bhongir College of Education, Hanumapur, Bhongir, Nalgonda Dt., Andhra Pradesh run by VJR Memorial Educational Society, Hanmapur, Bhongir, Nalgonda, Andhra Pradesh vide SRC (NCTE) order no. F.AP/B.Ed/New/42/SRO/NCTE/2000-2001/1584 dt. 14.08.2000 for conducting B.Ed. course of one-year duration with an annual intake of 120 students.

- 2. AND WHEREAS, the institution has submitted it written representation on 1.3.2012 along with DD of Rs.50,000/- (expired) stating therein to inspect the new own premises of the institution.
- 3. AND WHEREAS, the SRC in its 251 meeting considered the case of the institution and decided to cause Composite inspection for B.Ed. (APSO 0047) & APSO 2804 (D.Ed.) course being run by the institution.
- **4. AND WHEREAS,** the SRC in its 255th meeting decided to reject the recognition on the following grounds:-
 - * The institution has not submitted, original FDRs of Rs 5 & 3 lacs towards endowment and reserve fund in joint account.
- 5. AND WHEREAS, the SRC in 255th meeting decided to 'Reject' the application instead of withdrawal of recognition. The SRC in its 256th meeting held on 04-06th December, 2013 has reviewed the decision taken in its 255th meeting, decided to correct the mistake of decision as 'Reject and change it to withdrawal of recognition w.e.f 2013-14. As per the decision of SRC, a withdrawal order was issued to the institution on 07.01.2014.
- **6. AND WHEREAS**, aggrieved by the withdrawal order of SRC, the institution filed an appeal before the appellate authority, NCTE Hqrs. The appellate authority order F.No.89-43/2014 Appeal/6th Meeting-2014/ A88441 dated 29/05/2014 is received by this office on 16/06/2014 has ordered as under: -
 - "Dr. M. Niranjan Reddy, Secreatry, Bhongir College of Education, Nalgonda, Andhra Pradesh presented the case of the appellant institution on 17-04-2014. In the appeal and during personal presentation it was submitted that "as per SRC NCTE office letter No. SRO/NCTE/2009-10/14035 dt. 12-06-2009, we have deposited endowment fund of Rs. 5 lacs under FDR No. 671729 and Reserve fund Rs. 3 lacs

under FDR No.671732 pertaining to B.Ed .course and Rs.5 lacs under FDR no.671734 and Reserve fund Rs.3 lacs under FDR 671731 pertaining to the D.Ed. course of the institution with the Indian Oversease Bank. Padmarao Nagar Branch Hyderabad. It's further submitted that the said FDR receipts stood in the name of our institution as well."

Appeals Committee noted that recognition for conducting B.Ed. course of the appellant Institution has been withdrawn by SRC vide order dated 07-01-2014 simply and solely on the ground that the institution has not submitted original F.D. Rs. of 05 & 3 lacs towards endowment & reserve fund in joint account. The appellant during the course of appeal hearing produced copy of the SRC letter no. SRC/NCTE/ACCTS/2010-11/24301 dated 18/11/2010. The contents of this letter reveal that original F.D. Rs. bearing no. 671729 and 671732 amounting to Rs. 5 and 3 lacs respectively were seen in original and verified by office of SRC and returned to the appellant institution.

Appeals Committee further noted that an inspection of the appellant institution was conducted on 08-10-2013 for assessing suitability of the premises where the appellant institution was proposed to be located. On page 3 of the Inspection Report the V.T. members have made entries to the effect that F.D.Rs. fro Rs. 5 & 3 lacs respectively have been verified in original. There was also no Show Cause Notice issued to the appellant institution in terms of proviso to section 17(1) of the Act. Appeals Committee therefore, concluded that the withdrawal order dated 07-01-2014 issued by SRC deserves to be set aside and case be remanded back to SRC with a direction to process further the proposal to grant permission for shifting the institution from one premise to the other.

After perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Council concluded that the appeal deserves to be remanded to SRC with a direction to process further the proposal to grant permission for shifting the institution from one premise to the other.

The Council hereby <u>remands back the case</u> of Bhongir College of Education, Nalgonda, Andhra Pradesh to the SRC, NCTE, for necessary action as indicated above."

- 7. **AND WHEREAS**, the SRC in its 269^{th} meeting held on 1-2 July, 2014 considered the matter as per the direction of NCTE (H'qrs) that all appeal remand cases should be processed only after notification of the new Regulations. Advised Southern Regional Office to process the case accordingly, and put up after notification of new Regulations as per NCTE (H.Q) instructions.
- **8. AND WHEREAS,** the institution has submitted the following documents along with affidavits requesting to process the application as per Regulation 2014. Thereafter, the matter was considered in 276th Meeting of SRC held on 7th-9th January, 2015 and decided as under: -

- 1. Restore recognition
- 2. Permit shifting
- 3. Issue Revised Provisional Recognition Order
- 9. AND WHEREAS, the SRC vide order no. F.SRO/APSO0047/B.Ed/AP/2015/61088 dt. 20.1.2015 was issued a order to the institution for shifting of premises to new location at Bhongir College of Education, Sy. No. 131/0, 132, Anantha Puram Village, Bhongir Mandal, Nalgonda District-508116, Andhra Pradesh.
- 10. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt. 25.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 18.03.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 11. AND WHEREAS, the institution vide letter dated 16.02.2016 submitted written representation regarding change in the name of the State from Andhra Pradesh to Telangna. The SRC vide order no F.SRO/NCTE/APSO0047/B.Ed/TS/2016/81852 dated 16.02.2016 issued a corrigendum to this effect.
- **12. AND WHEREAS,** a letter No. F.No. SRO/NCTE/APSO0047/B.Ed/VT/TS/2016-2017/86370 dated 14.6.2016 was issued to the institution for inspection as per direction of SRC for B.Ed. course. However the inspection of the institution was not conducted.
- 13. AND WHEREAS, the SRC in its 369thmeeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 21.02.2019. The institution did not submit reply to the show cause notice till date.
- 14. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st, Nov, 2019 considered the matter and decided to issue to issue SCN in all such matters where the institution has not submitted reply to SCN. Accordingly, a Final Show Cause Notice was issued to the institution on 14.11.2019. The institution submitted its reply to the Final Show Cause Notice vide letter dt. 06.12.2019 along with documents. The matter of the institution was finally considered by the SRC in its 385th meeting held on 03rd March, 2020 and decided as under:-

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the original documents and records submitted by the institution. The Committee decided that the continuation order be issued to Bhongir College of Education, Nalgonda District- 508116, Telangana for B.Ed programme for 2 basic units (50 students each).

15. NOW THEREFORE, this order is issued permitting the institution i.e. Bhongir College of Education, Sy. No. 131/0, 132, Anantharm Village, Bhongir (M), Nalgonda District-508116, Telangana run by VJR Memorial Educational Society, Sy. No. 131/0, 132,

Anantharm Village, Bhongir (M), Nalgonda District-508116, Telangana for continuation of recognition for B.Ed course of two years duration with an intake of (two units) of 50 students each subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **16.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 17. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 18. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students:
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter:
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 19. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 20. The institution shall make available the list of students admitted on its official website.
- 21. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
