WHEREAS, recognition was granted to the institution namely Yanamadala Kamala College Visakha S. Kota. **Division** Revenue Vizianagaram Education. by Yanamadala Kamala Andhra Pradesh run Vizianagaram District-535145, 535145, Andhra Pradesh vide SRC Educational Society, S. Kota, Vizianagaram District-(NCTE) order no. F.AP/NEW/B.Ed/110/SRO/NCTE/2002-2003/7964 dt. 03.07.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2002-2003.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is affidavit dt. 03.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, thereafter, revised provisional recognition order was issued to the institution on 11.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 03.05.2019. The institution did not reply to the show cause notice till date.

AND WHEREAS, the SRC in its 378th meeting held on 25th & 26th July, 2019 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC a final show cause notice was issued to the institution on 30.07.2019. The institution submitted its reply to the Final Show Cause Notice on 19.08.2019 along with documents.

AND WHEREAS, the SRC in its 383rd Meeting held on 7th, 8th and 9th January 2020 considered the matter and decided as under:-

The Management of the Institution had not submitted required documents in response to Show Cause Notice (SCN) issued to the Institution on 03.05.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 30.07.2019. The institution vide letter dated 01.11.2019 submitted its reply/representation in response to Final Show Cause Notice (FSCN). On perusal of the same the Committee found the following defects / shortcomings / deficiencies as per provisions of the NCTE Regulations, 2014 which are as under:-

Andhra University. The Principal & One lecturer do not possess M.Ed. The institution has not appointed the faculty of Performing Arts. The institution has appointed only 9 faculties against the requirement of 1+15 for 2 basic units of B.Ed as per NCTE Regulations, 2014.

2. The Committee also observed that the institution has not shifted to new premises.

Hence, the Committee decided to withdraw the recognition granted to Yanamadala Kamala College of Education, Vizianagaram Revenue Division Visakha Road, S. Kota, Vizianagaram Dt-535145, Andhra Pradesh for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
