WHEREAS, recognition was granted to the institution namely St. Merry Stella College of Education, Eluru Revenue Division, Padatadepalli, Totepalligudem Mandal, West Godavari District- 534101, Andhra Pradesh run by David Memorial Socio Educational Association Pedatadepalli, Todepalligudem Mandal, West Godavari District, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.Ed/114/SRO/NCTE/2002-2003/6707 Dt. 04.04.2003 for conducting B.Ed. course of one-year with an annual intake 120 students from the academic session 2002-2003.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt. 08.04.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, thereafter, provisional revised recognition order was issued to the institution on 11.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, SRC in 381th meeting decided to issue Show Cause Notice to all such institution where reply to RPRO/VT report has not been submitted by the institution. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 06.12.2019. The institution did not submit the reply to the Show Cause Notice.

AND WHEREAS, the SRC in its 383<sup>rd</sup> Meeting held on 7<sup>th</sup>, 8<sup>th</sup> and 9<sup>th</sup> January 2020 considered the matter and decided as under:-

- The Management of the Institution had not submitted required documents in (i) response to Show Cause Notice (SCN) issued to the Institution on 06.12.2019.
- The Dean, Adikavi Nannaya University, Andhra Pradesh vide letter No. (ii) No.ANUR/CDC/Edu./NCTE/Information/2019-20/01 dated 19.11.2019. informed that the University has discontinued the extension of affiliation from the academic year 2016-17 to 2019-20 in respect of the institution St. Merry Stella College of Education, Eluru Revenue Division, Padatadepalli, Totepalligudem Mandal, West Godavari District- 534101, Andhra Pradesh."

Hence, the Committee decided to withdraw the recognition granted to St. Merry Stella College of Education, Eluru Revenue Division, Padatadepalli, Totepalligudem Mandal, West Godavari District- 534101, Andhra Pradeshfor conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-
